Suite 5B is a well maintained office suite with upgraded LED lighting and communal male and female WCs. This Suite is available from October 2025.

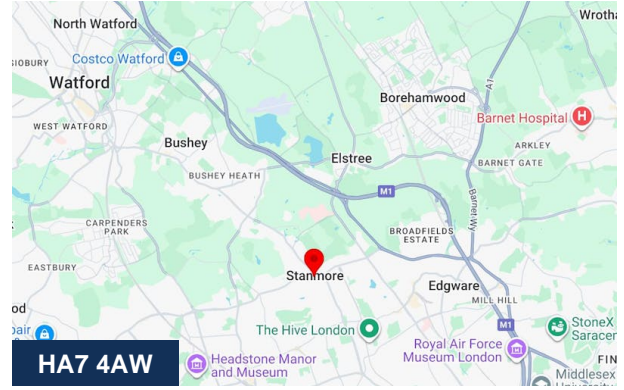
Location
