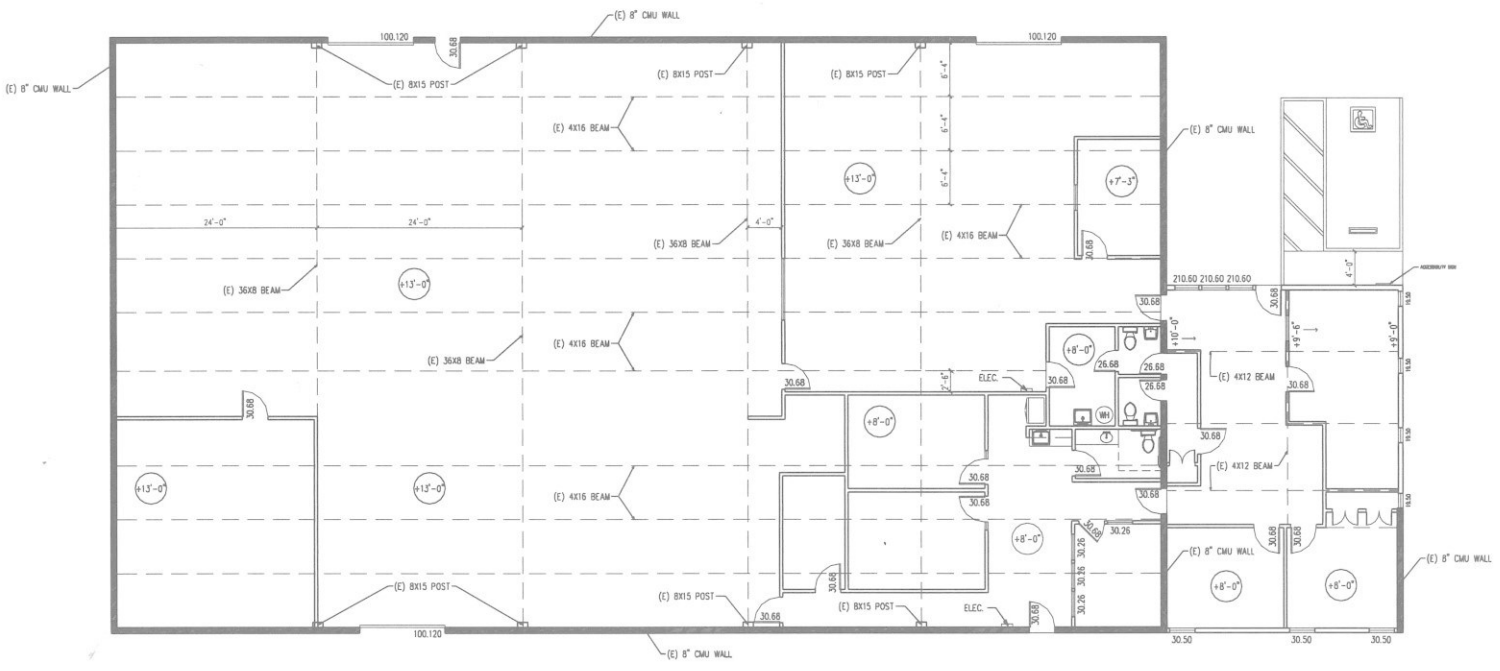

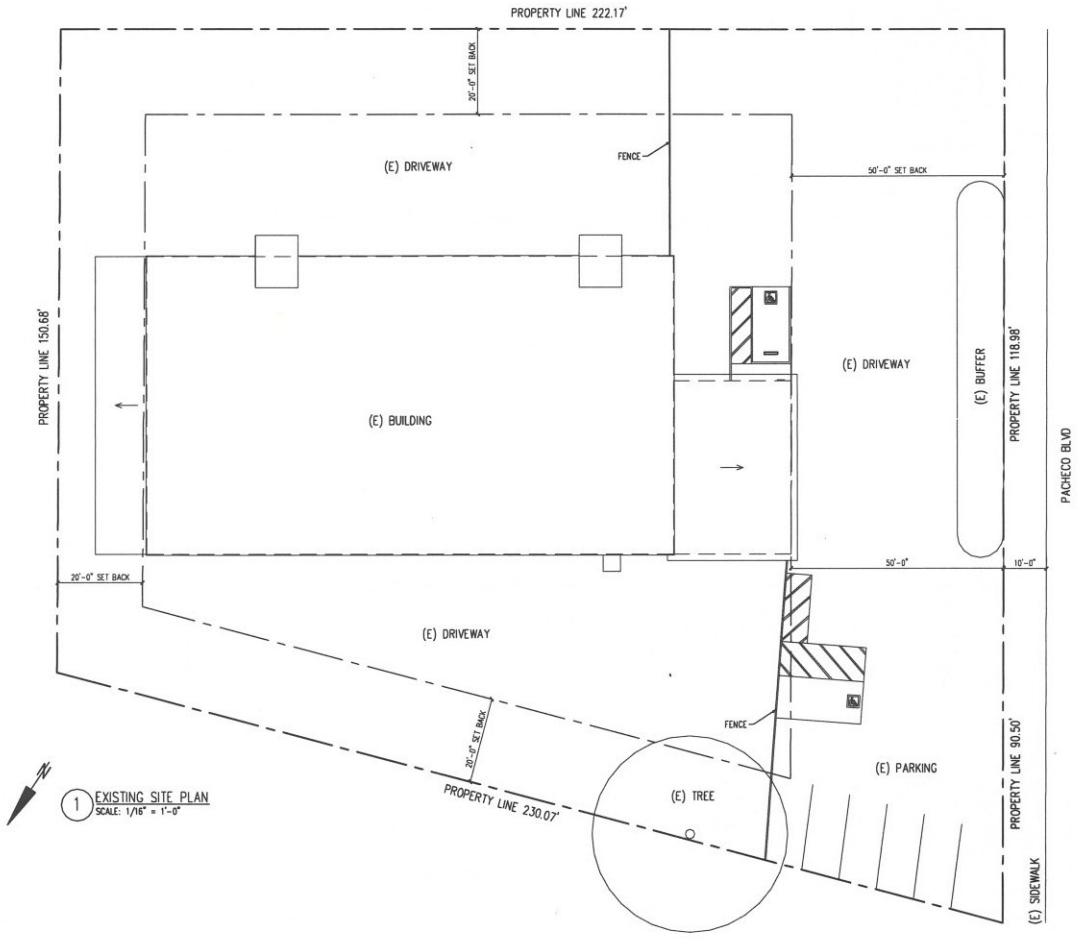


1 EXISTING FLOOR PLAN

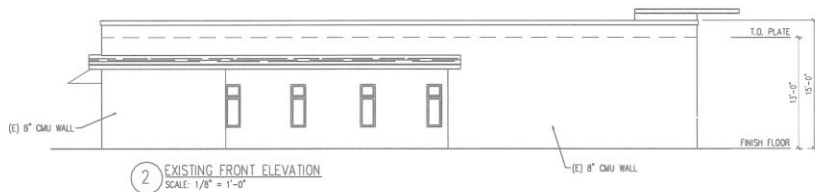

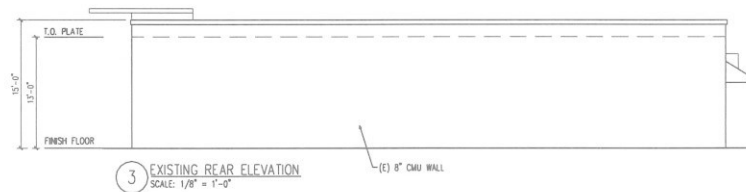

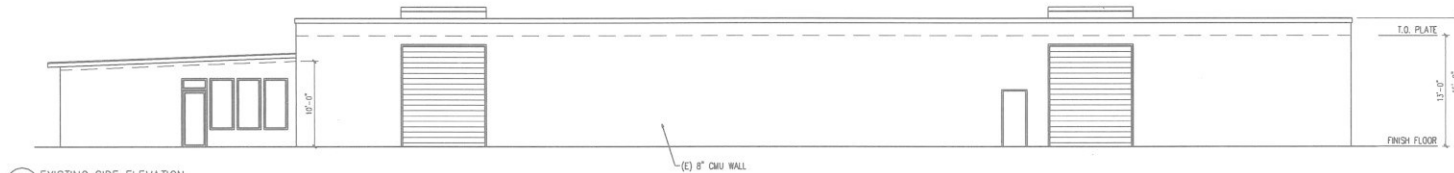

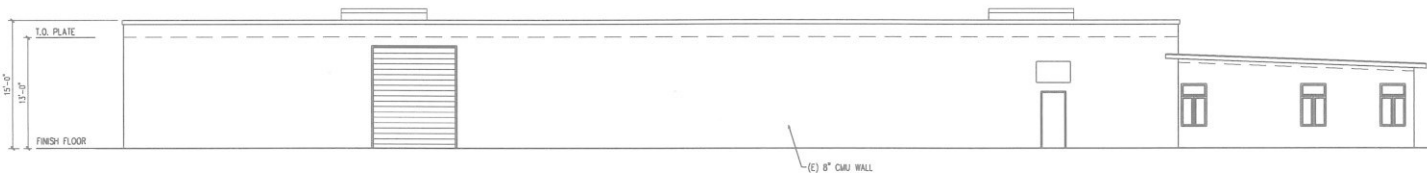
2 EXISTING FRONT ELEVATION
