The premises consists of three rooms on the second floor of Portmore House. Portmore House, originally the Dower House to the Portmore Estate is believed to date from 1680. It is now Grade II listed, but has undergone many changes during its life. The offices can be described as character offices and benefit from kitchenette facilities.

## Location

The premises are well situated in central Weybridge, which is approximately 16 miles south west of Central London. J11 of the M25 is approximately 2.5 miles distance and J10 of the M25, which can be reached via the A3, is approximately 3 mile distance.

Portmore House is placed directly opposite St James's Church in the heart of Weybridge. Church Street which is a continuation of the High Street provides a wide range of shopping and local amenities. Weybridge Mainline Railway Station provides frequent train services to London Waterloo (approximately 30 minutes journey time).

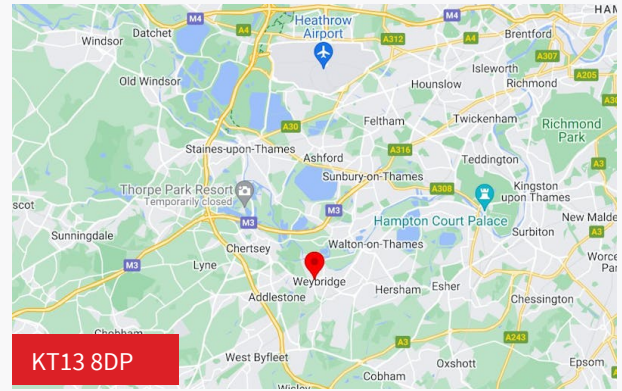
