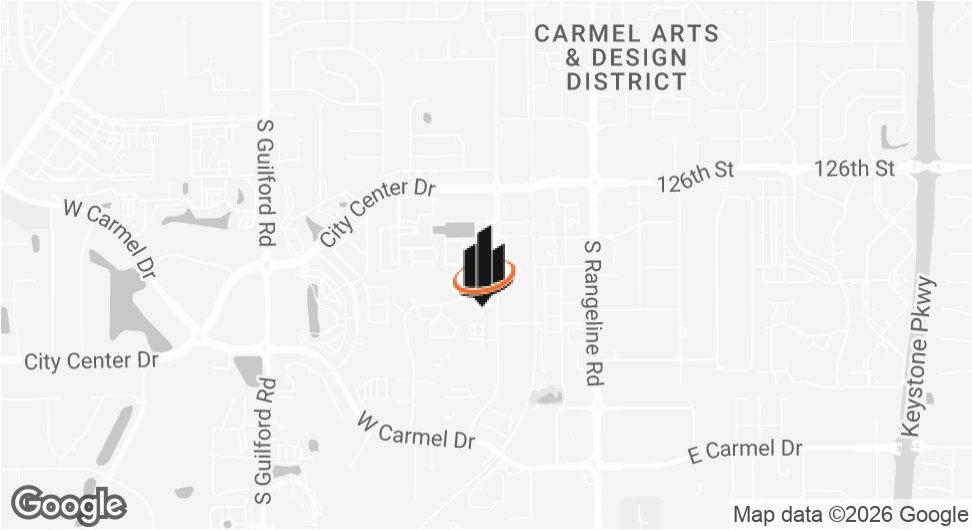

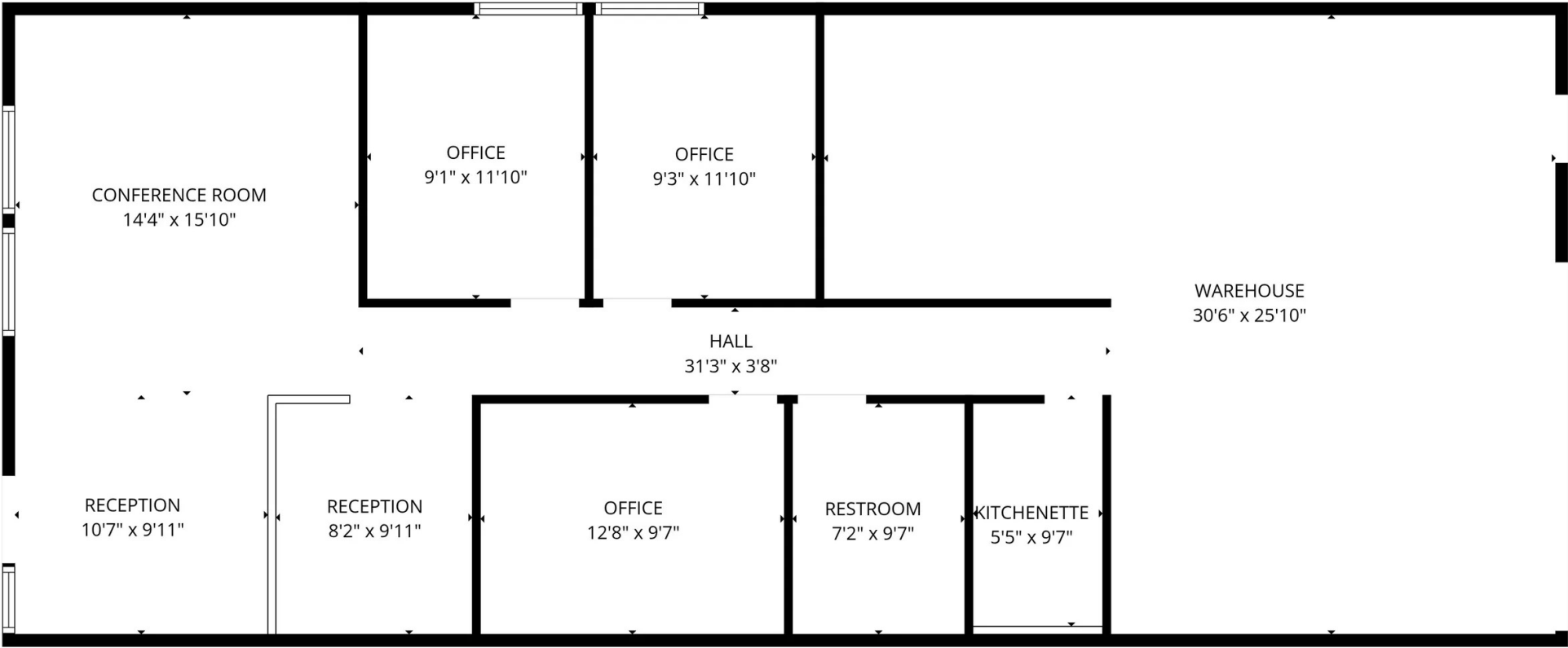

FLOOR PLANS



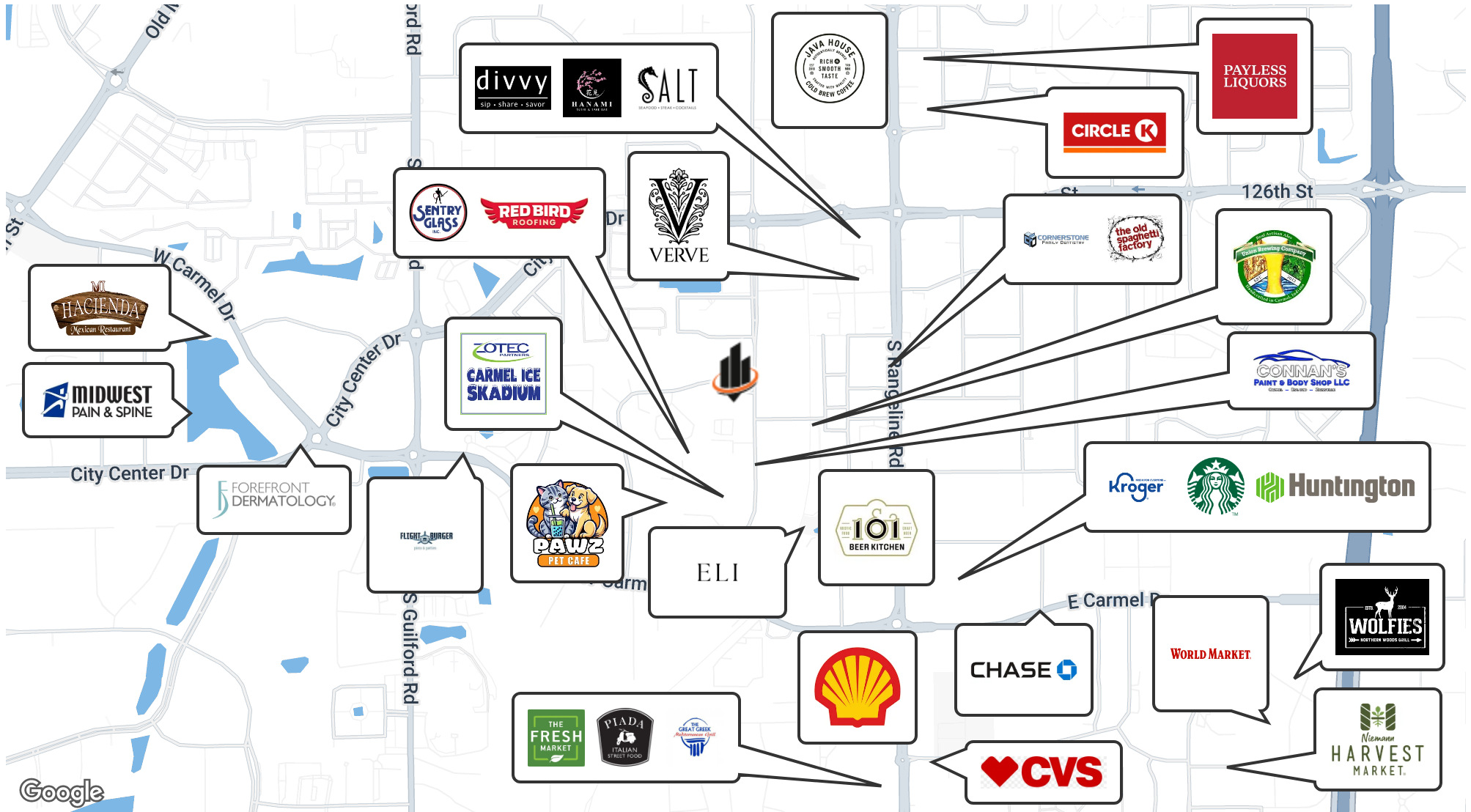

RETAILER MAP



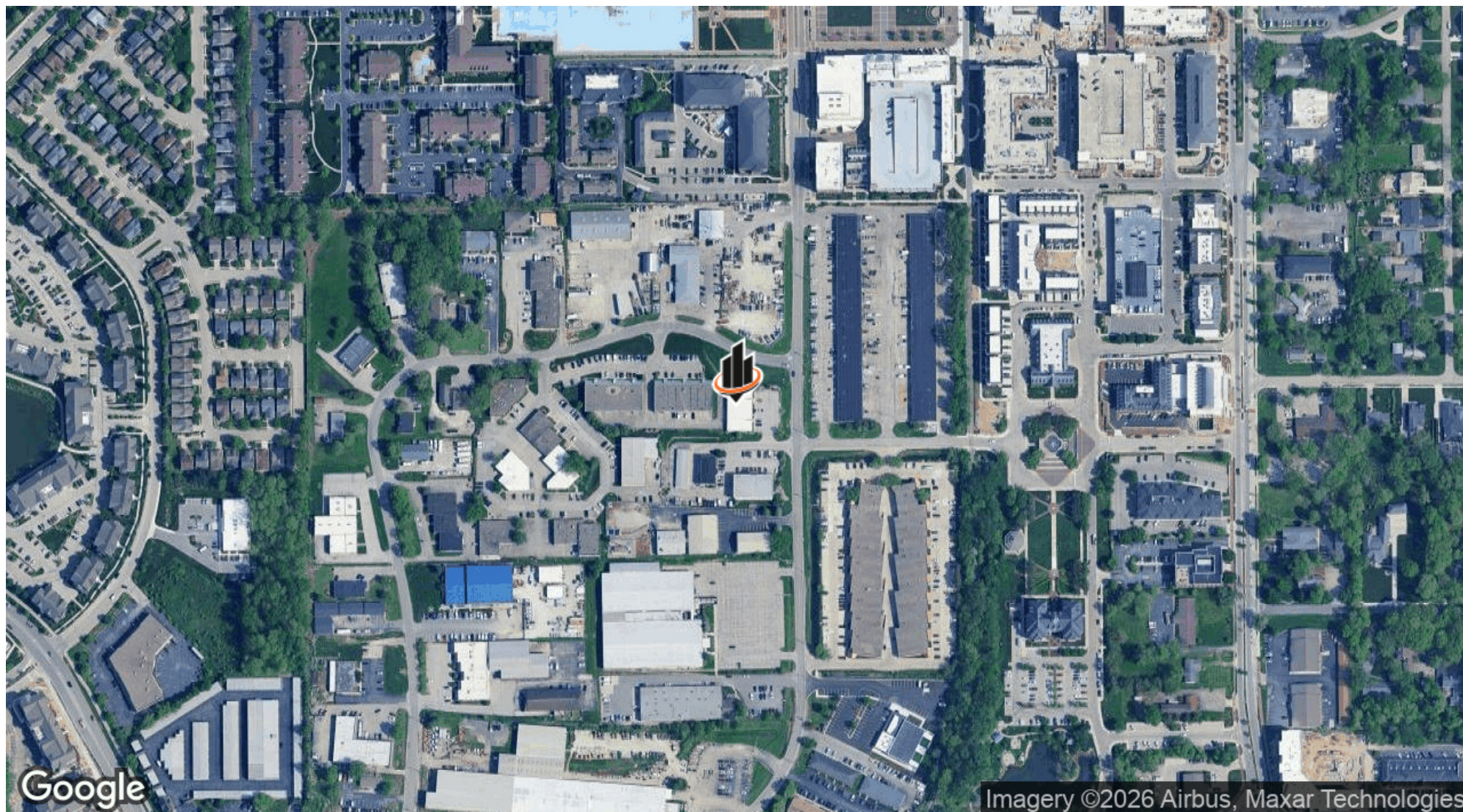
