## LOCATION

Crendon Industrial Estate is located approximately 5 miles from junction 7 and 8 of the M40 motorway, near Thame. This provides access to Oxford to the west, M25 and London to the south and the Midlands to the north.

The Park is located on the B4011, the main road between Thame & Bicester and is well served by public transport links. The estate currently provides over 500,000 sq ft of modern and refurbished accommodation.

## DESCRIPTION

The building is constructed of steel portal frame and situated within a terraced block. The pitched roof features profiled metal sheet cladding incorporating GRP roof lights and benefits from lifeline fall arrest systems. The elevations are clad with a combination of profiled metal cladding and feature facing brickwork panels surrounding the loading doors. Externally, an open forecourt is provided to the front elevation with 14 car parking spaces and loading / unloading area.
