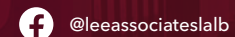

Key elements of this vision include:

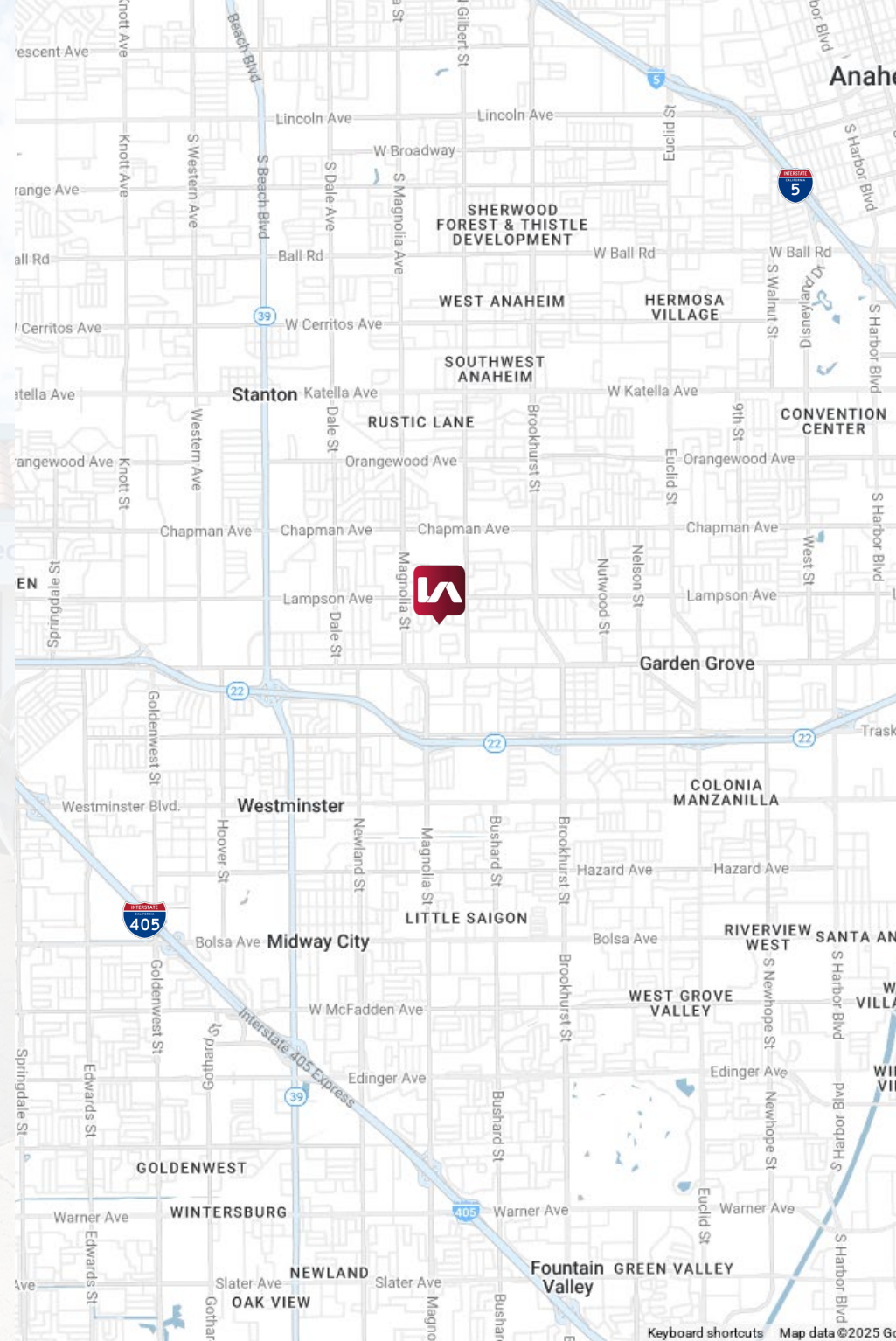
- Transitioning aging commercial properties into vibrant mixed-use environments with commercial, office, and residential uses.
