Description

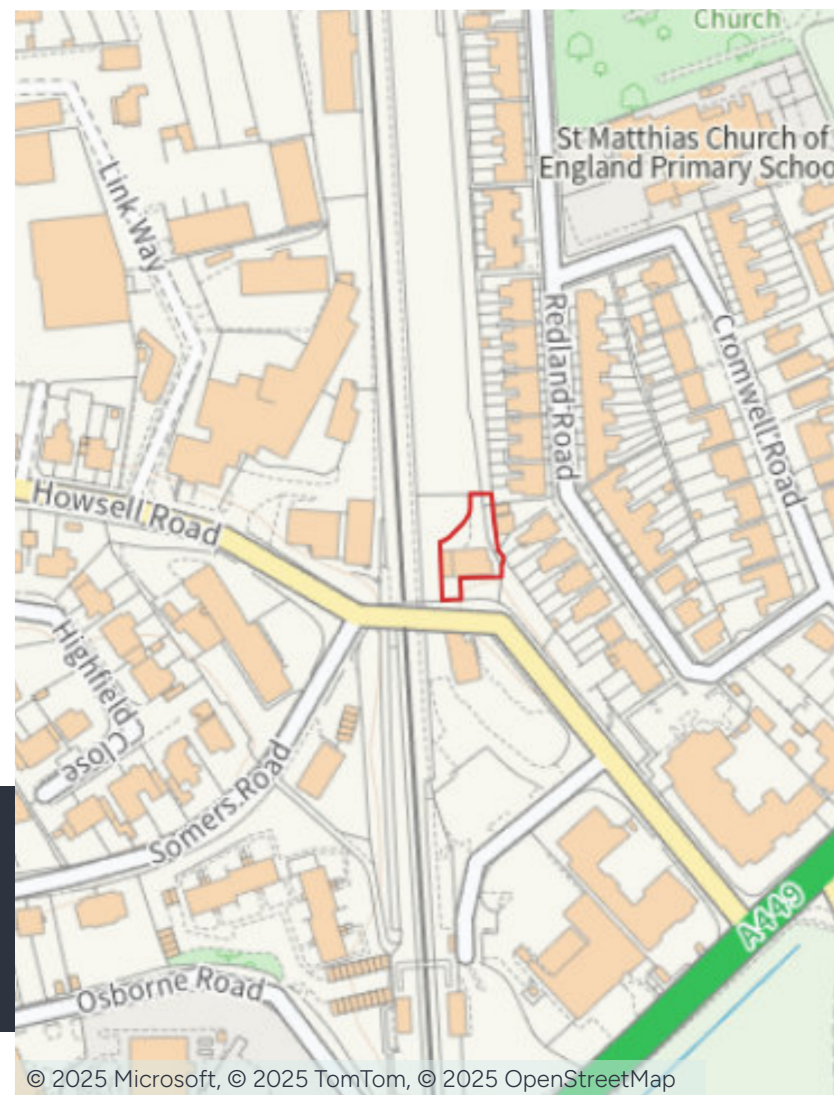

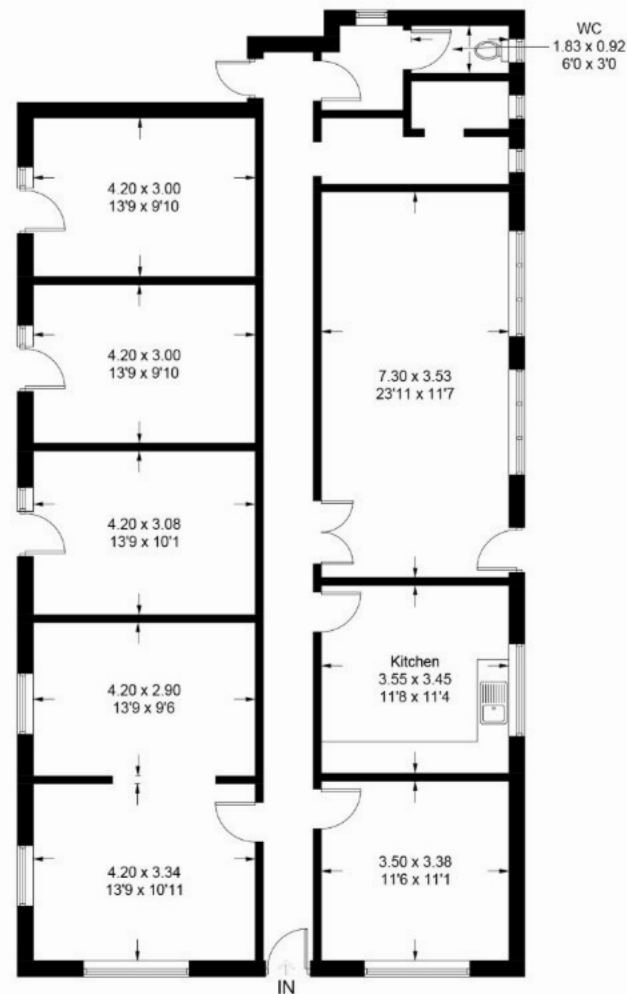

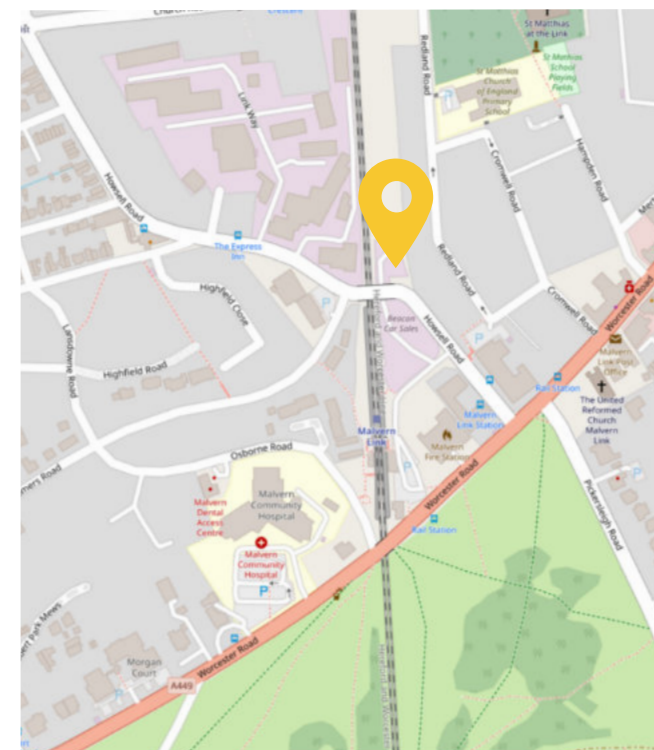
