Powell River Town Centre (the "Shopping Centre") serves as the region's primary shopping destination, anchored by Walmart, Save-On-Foods, Shoppers Drug Mart, Winners, CIBC, and BC Liquor Store. The Shopping Centre benefits from strong daily-needs traffic and serves as the central retail hub for Powell River and the surrounding trade area.

The Shopping Centre offers flexibility to accommodate a range of tenancy requirements, from smaller-format service users to larger contiguous footprints. These units are positioned near strong daily-needs anchors that drive consistent, all-day traffic throughout the centre.

Ownership is actively exploring the feasibility of creating exterior access for Units 67, 57, and 41, presenting a unique opportunity to capture both internal mall traffic and direct exterior exposure. Positioned directly across from the bus loop, these units offer strong visibility and accessibility, an attractive format for food & beverage, service retail, and convenience-oriented users.

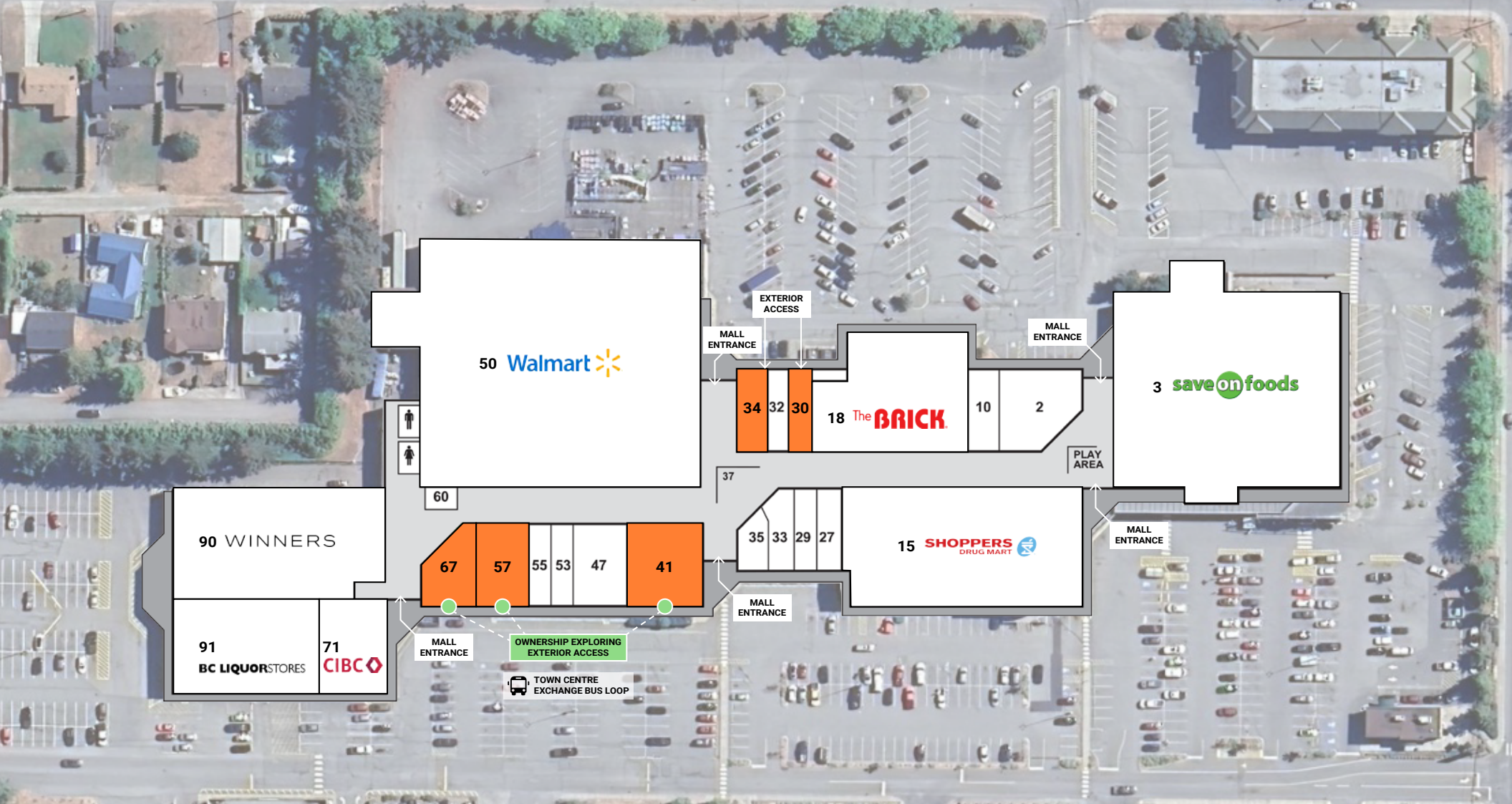

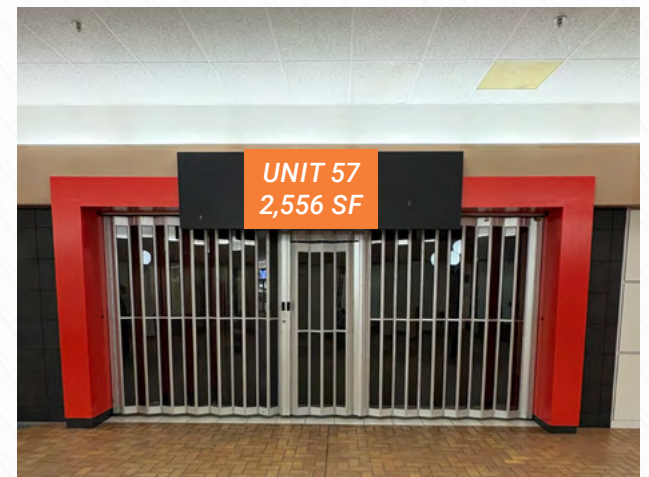
