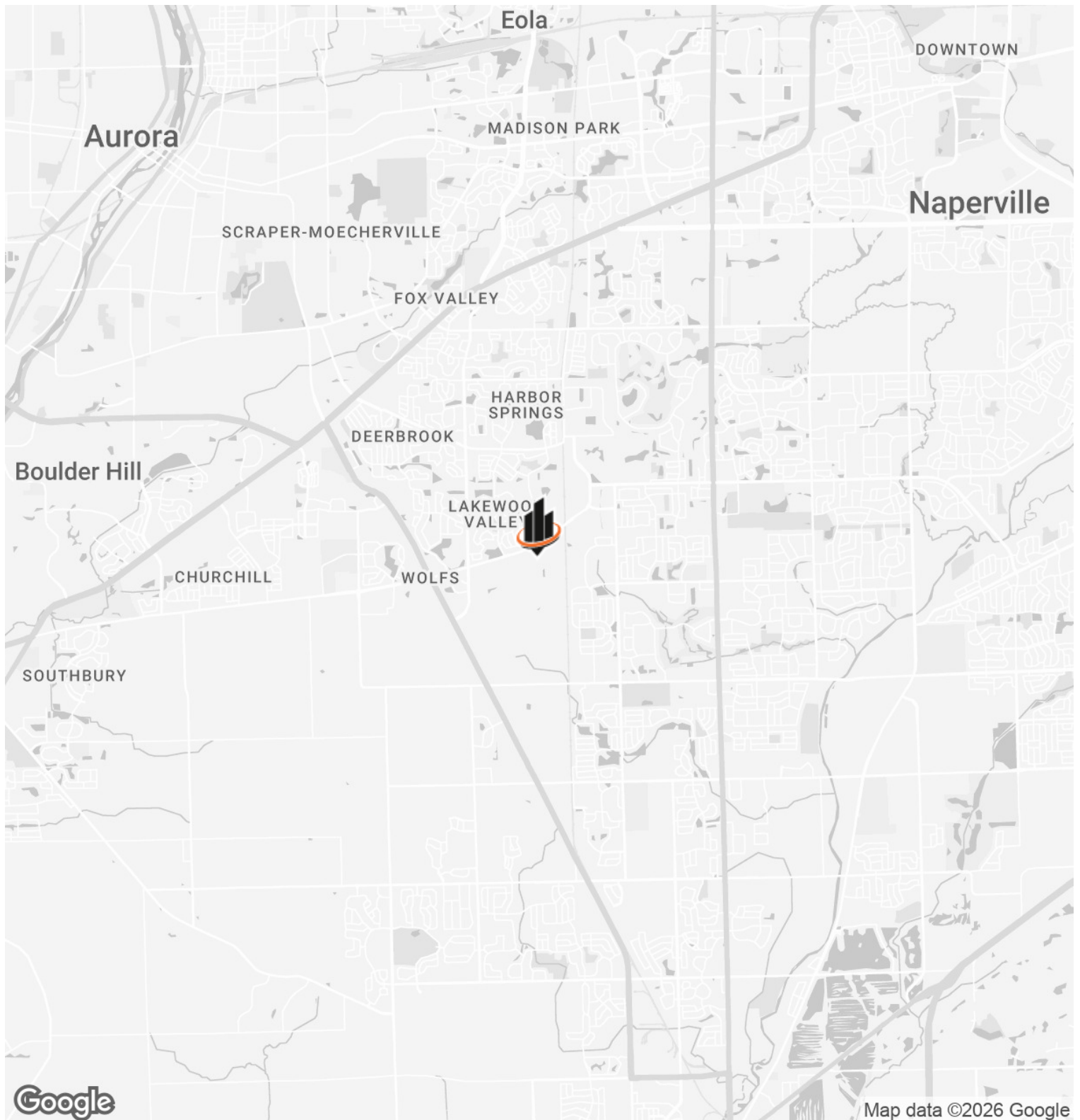

LOCATION MAP



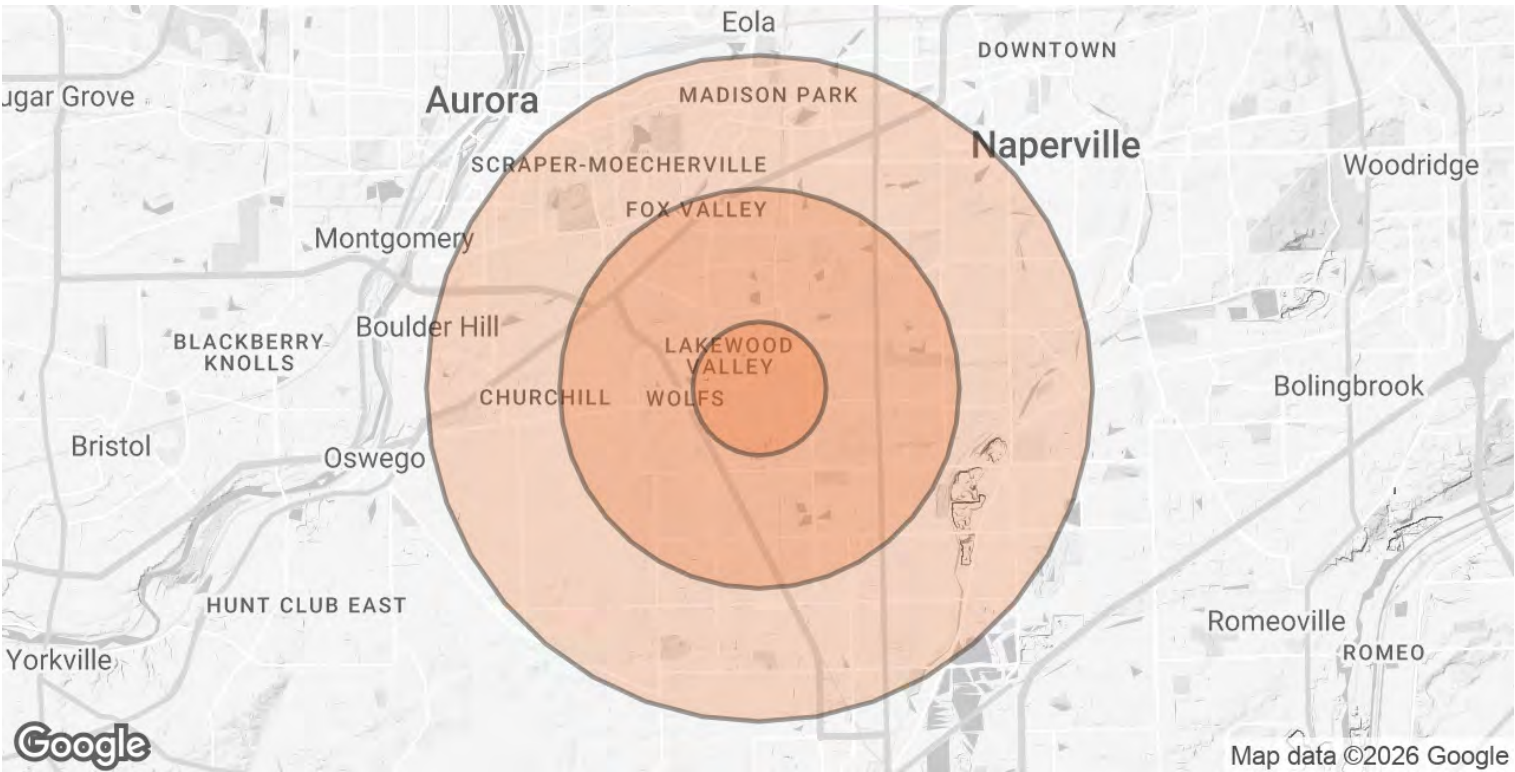
