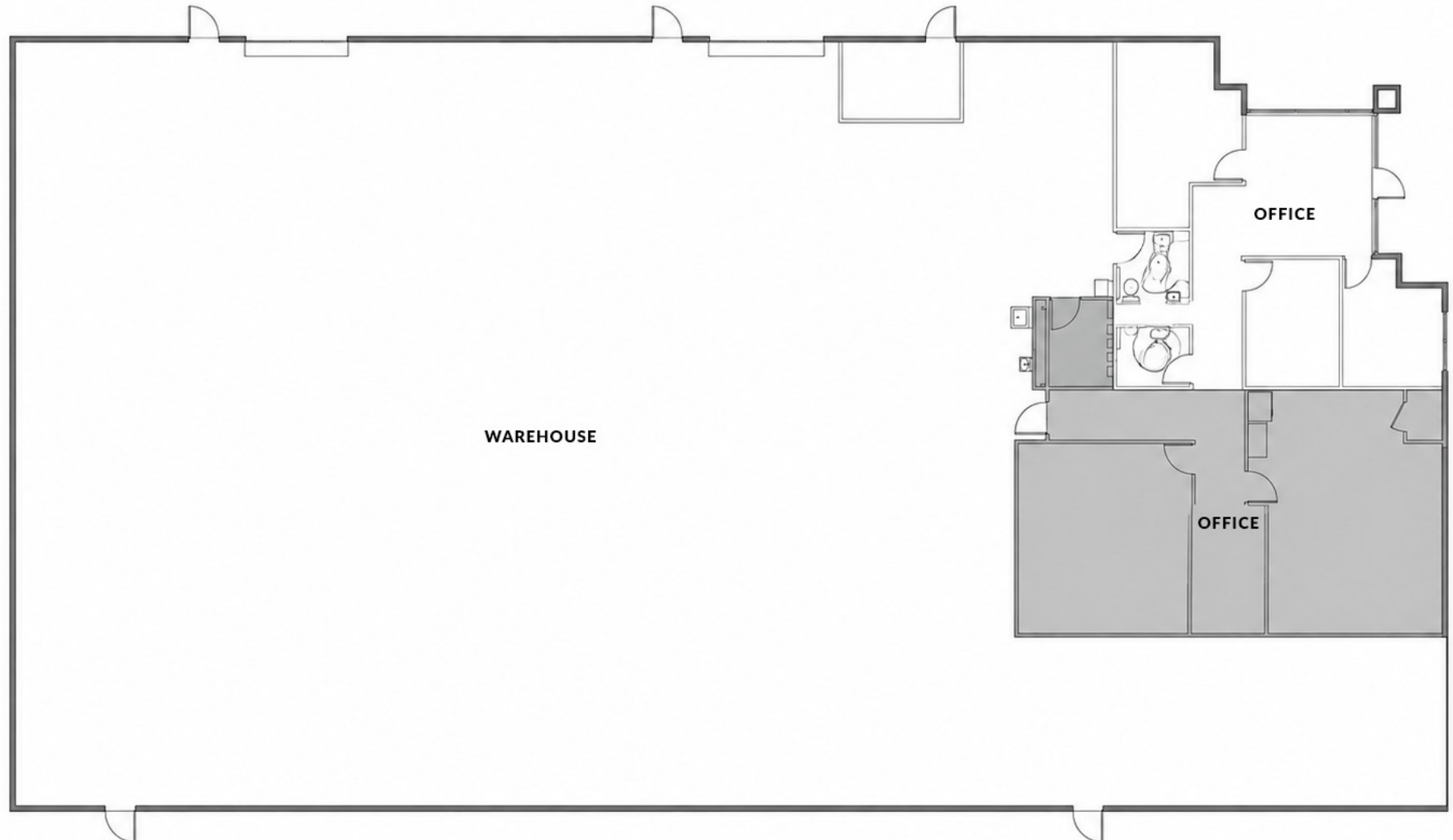


# FLOOR PLAN
