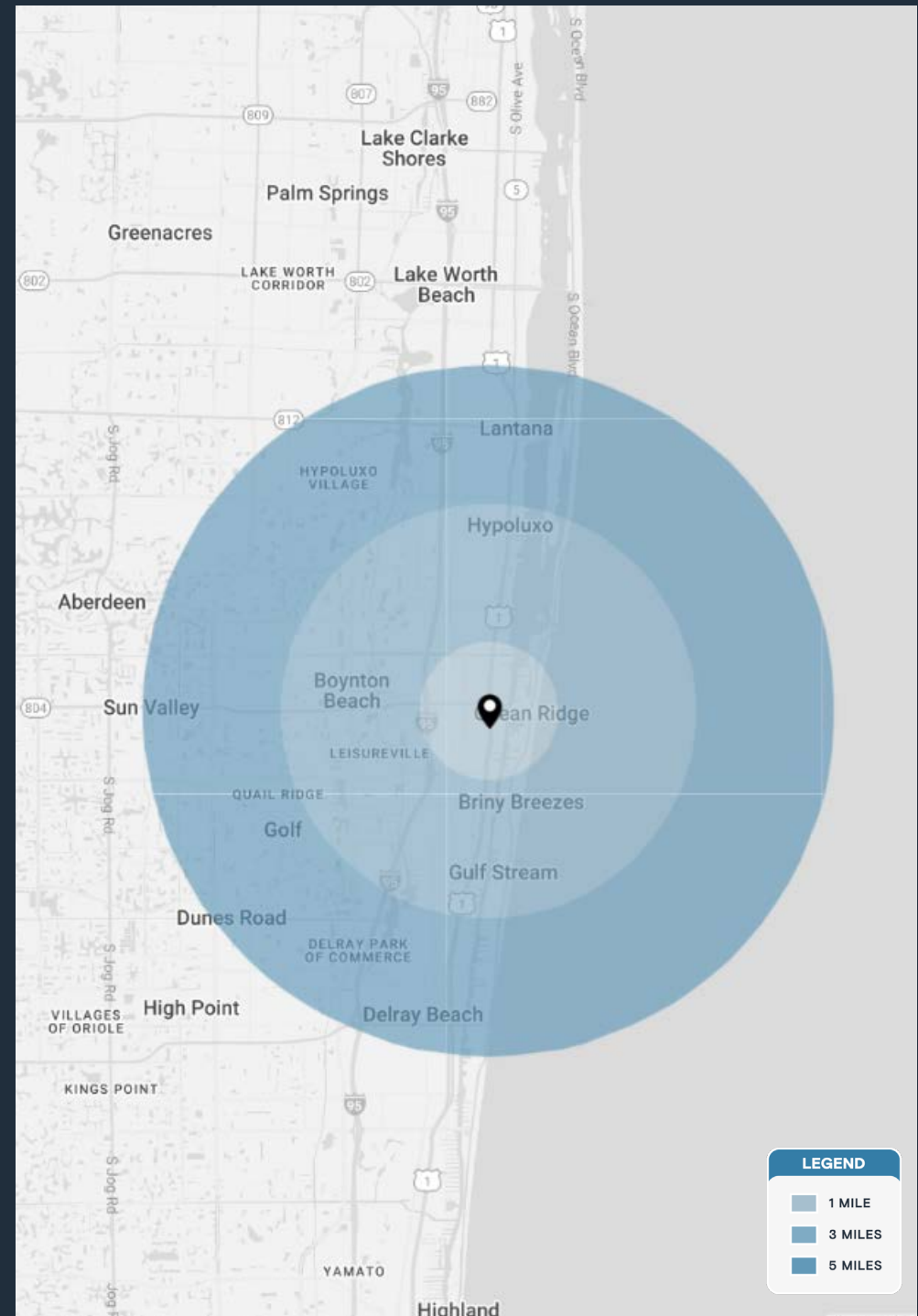
HIGHLIGHTS

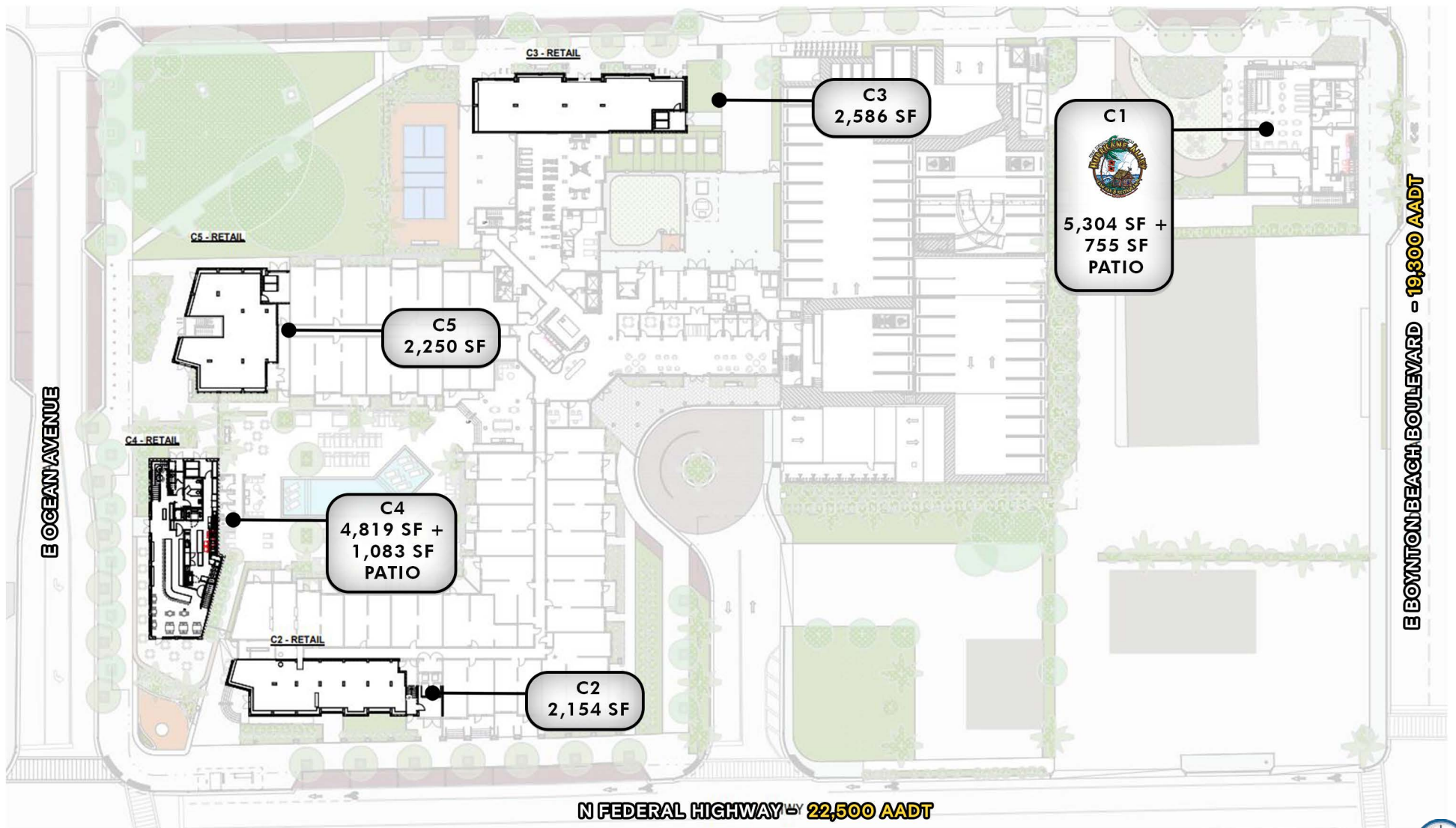

E BOYNTON BEACH BOULEVARD - 19,300 AADT

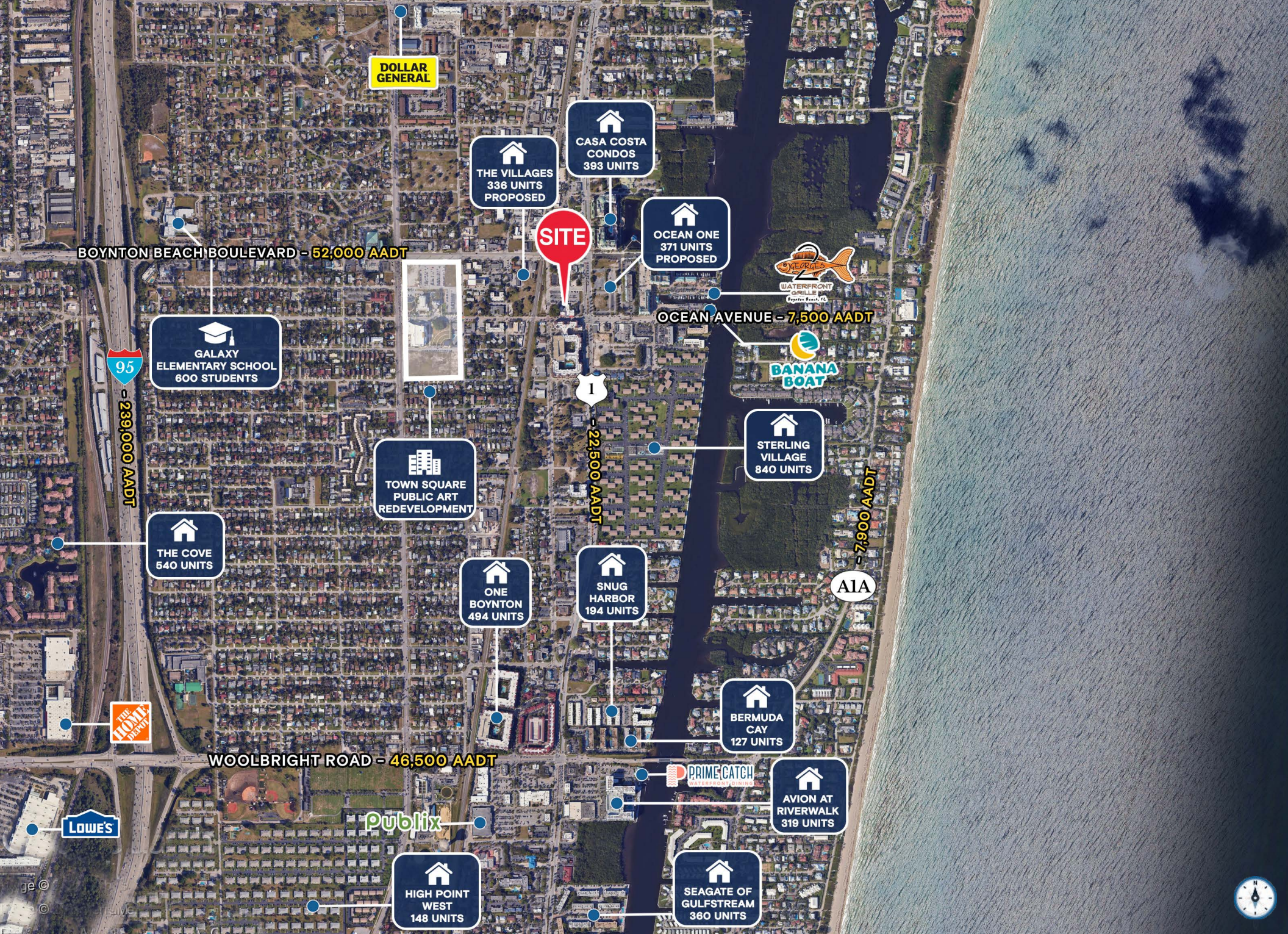


N FEDERAL HIGHWAY - 22,500 AADT
