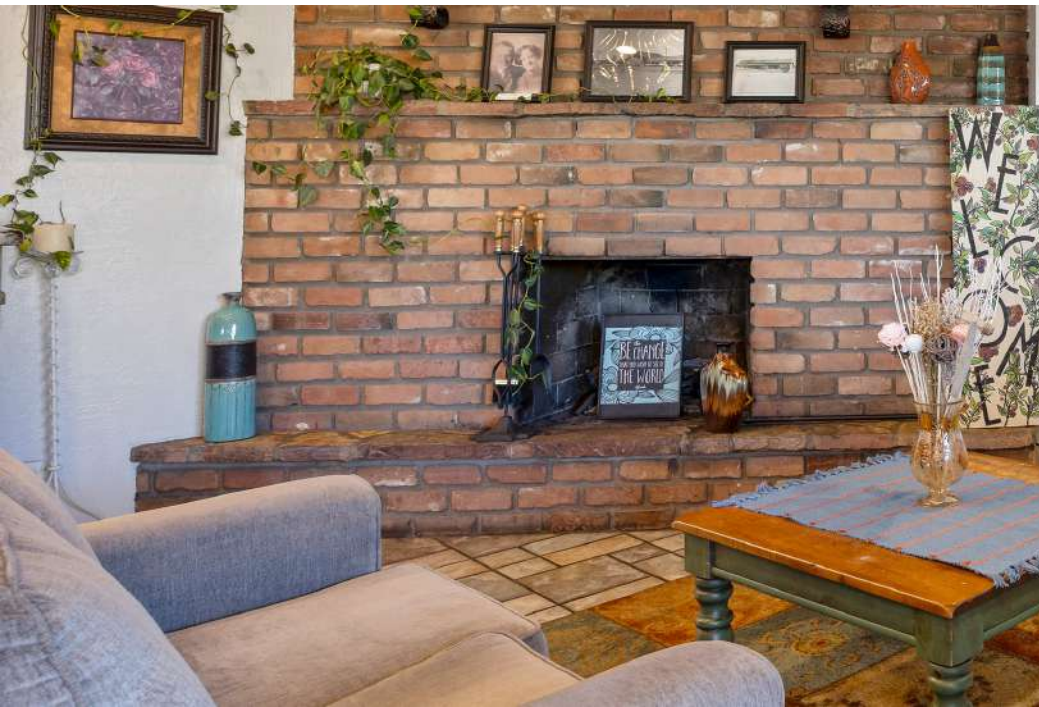

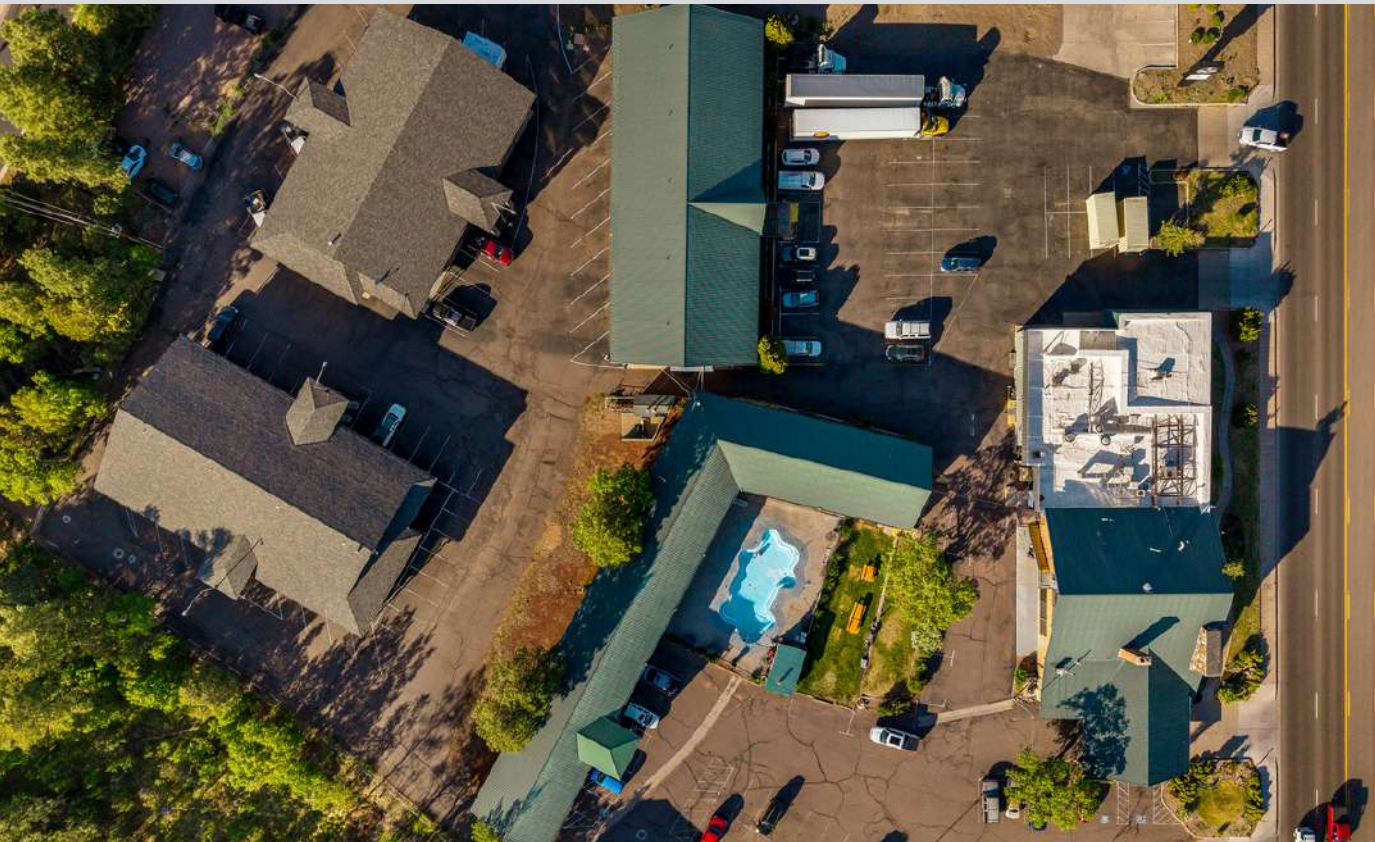

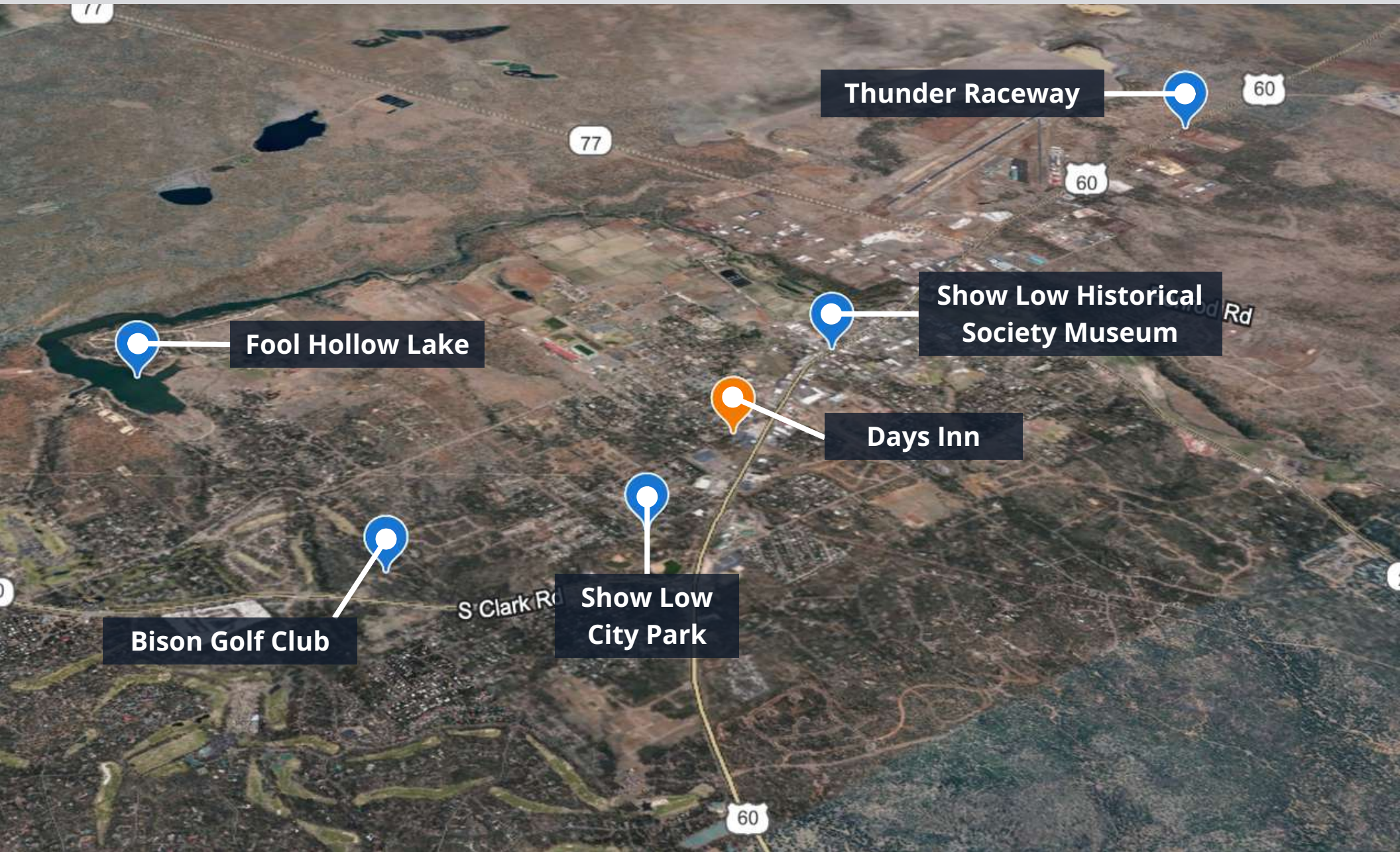
SHOW LOW HISTORICAL SOCIETY MUSEUM
