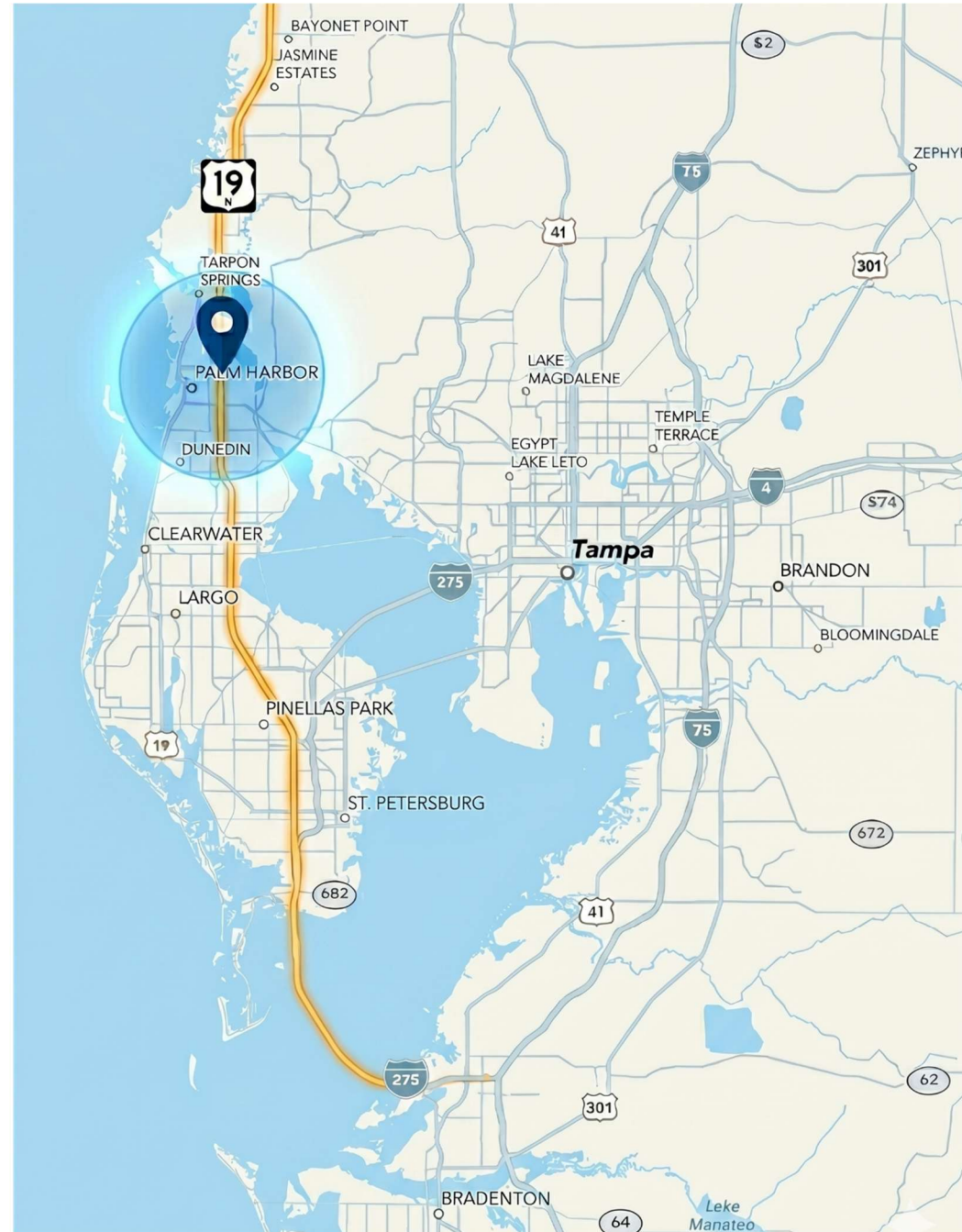

- Annual Average Daily Traffic: 93,000 cars per day as reported by FDOT

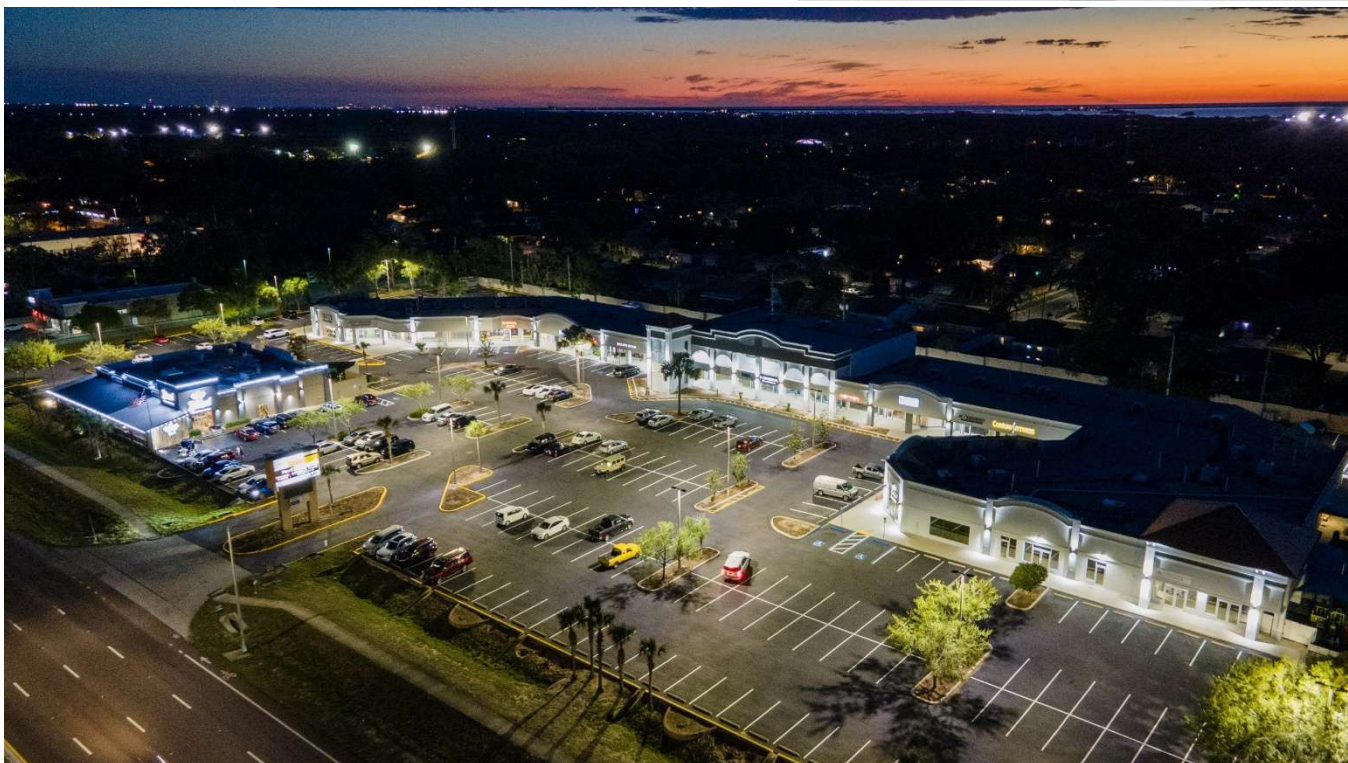
