LOCATION

Lancaster Park is a modern purpose-built business park comprising of industrial, storage and office premises situated off Newborough Road forming part of the B5234, and is approximately six miles from Burton upon Trent.

DESCRIPTION

The property comprises a modern end terraced industrial unit incorporating first floor office accommodation.

The unit is of steel portal frame construction having block / profile clad elevations beneath a pitched steel-clad roof with translucent rooflights and a solid concrete floor.

Internally, the unit provides a small warehouse area with additional mezzanine storage, the remainder of the unit is fitted out as offices over two storeys having a reception area, plus a range of offices, meeting rooms, break out areas, kitchen and WCs.

The unit is equipped with 3-phase electricity, along with an electric roller shutter loading door measuring 4.3m wide by 4.5m high. The office areas at both ground and first floor level are fully air conditioned.

Externally, the unit has the benefit of dedicated car parking spaces.

ACCOMMODATION

The property has been measured on a gross internal area basis in accordance with the RICS code of Measuring Practice (6th edition).

PLANNING

SERVICES

Mains electricity, water and drainage are available to the premises.

BUSINESS RATES

The subject property is listed on the Valuation Office website as having a rateable value of £45,000.

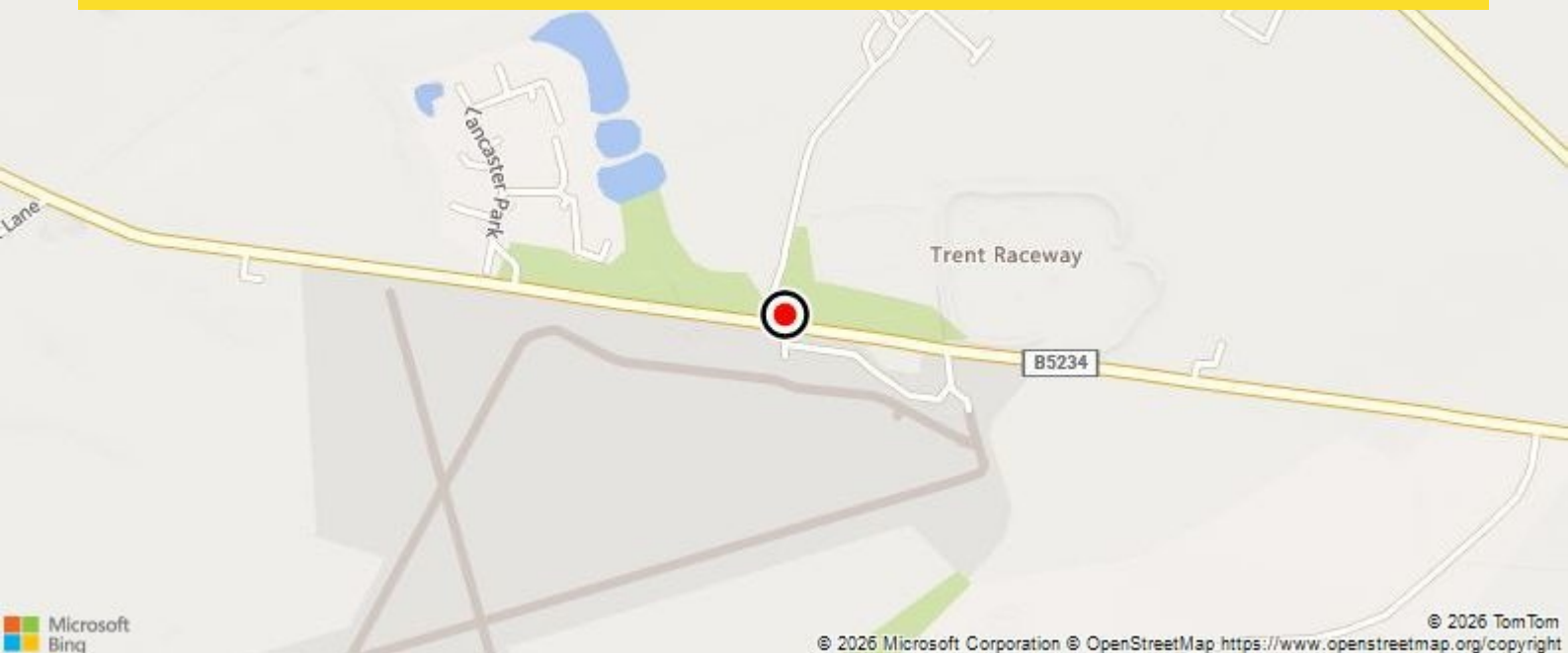
