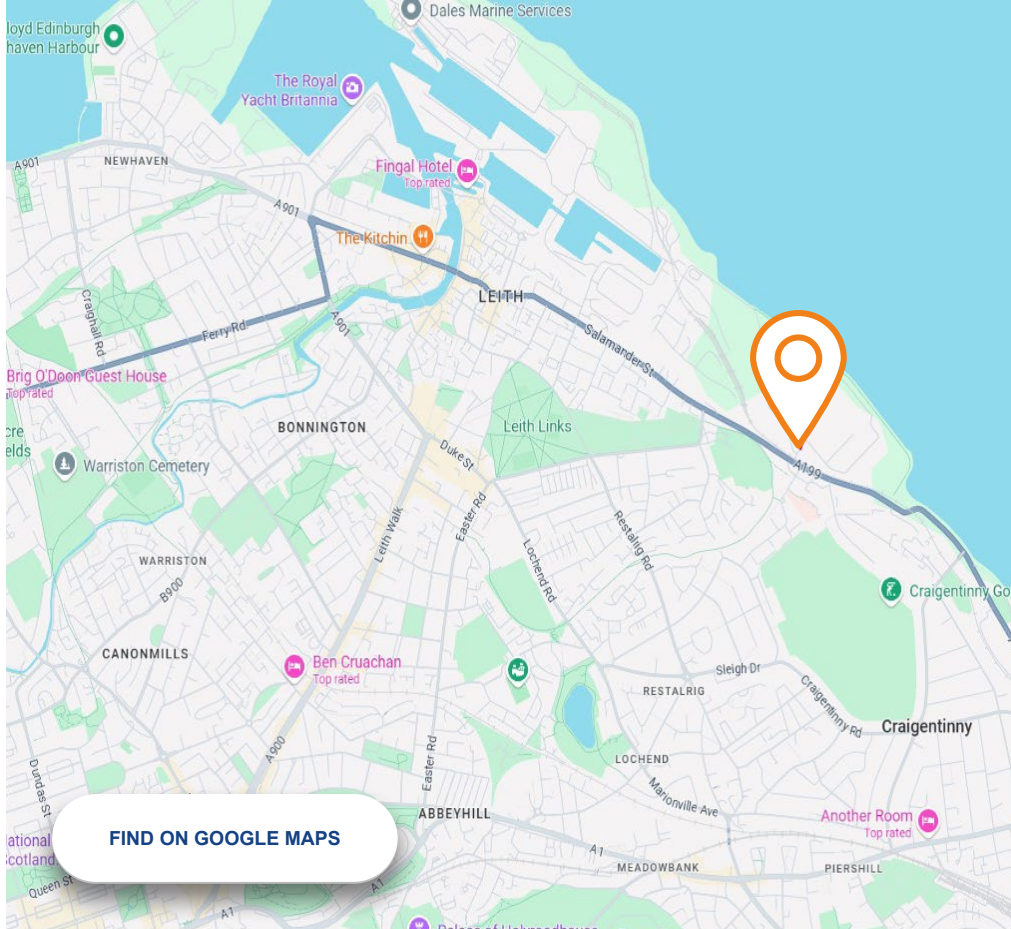

## LOCATION

3 Marine Esplanade is located within Edinburgh's popular Leith district, approximately 2.5 miles north east of the city centre.

The location is ideal for servicing Edinburgh, Leith and East Lothian. Marine Esplanade is accessed from Seafield Road (A199) which is the main arterial road connecting the north of Edinburgh to the A1 and East Lothian.

Surrounding occupiers include Forth Ports, Veolia Water, Shell Petrol Filling Station, Farmfoods, NWH Group and Bookspeed.

## DESCRIPTION

The premises comprise a high bay warehouse with a large yard / car park on a total site area of approximately 5 acres.

The building is of steel frame construction and benefits from a minimum eaves height of 6m rising to an average of 9m and 17m at the highest point.

Vehicular and pedestrian access is provided throughout offering a variety of subdivision options.

## ACCOMMODATION

The premises have been measured in line with the RICS Code of Measuring Practice (6th Edition) to provide a total Gross Internal Area of approximately 5,691 sq m (61,256 sq ft) and the total site area is 5 acres.

Warehouse space from 5,000 sq ft upwards and yards from 0.25 acres can be made available. The building can be subdivided to suit a variety of occupiers requirements.

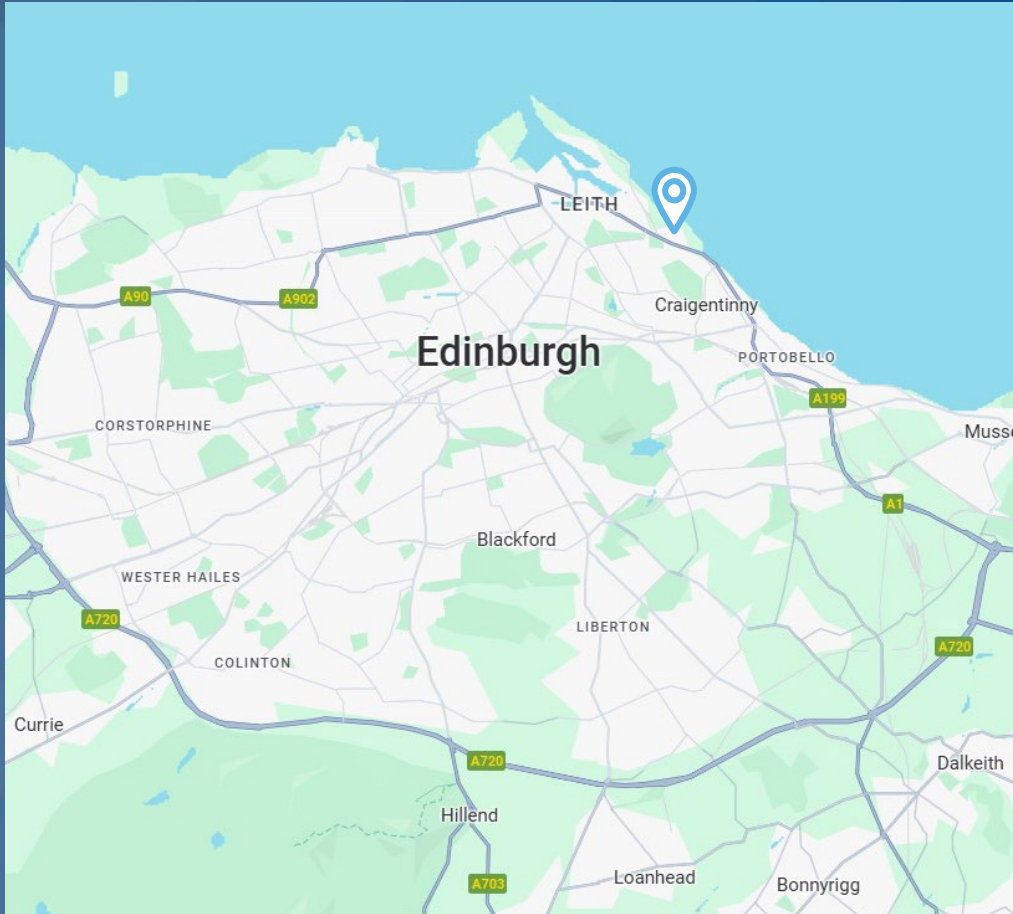
