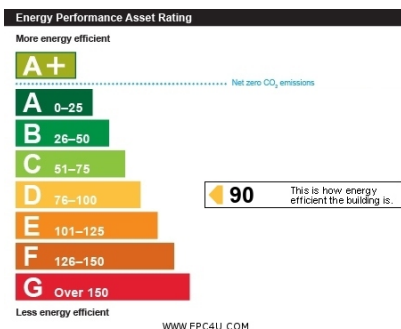
There are some private offices, storage space, Car Parking, WCs and a Kitchen.
