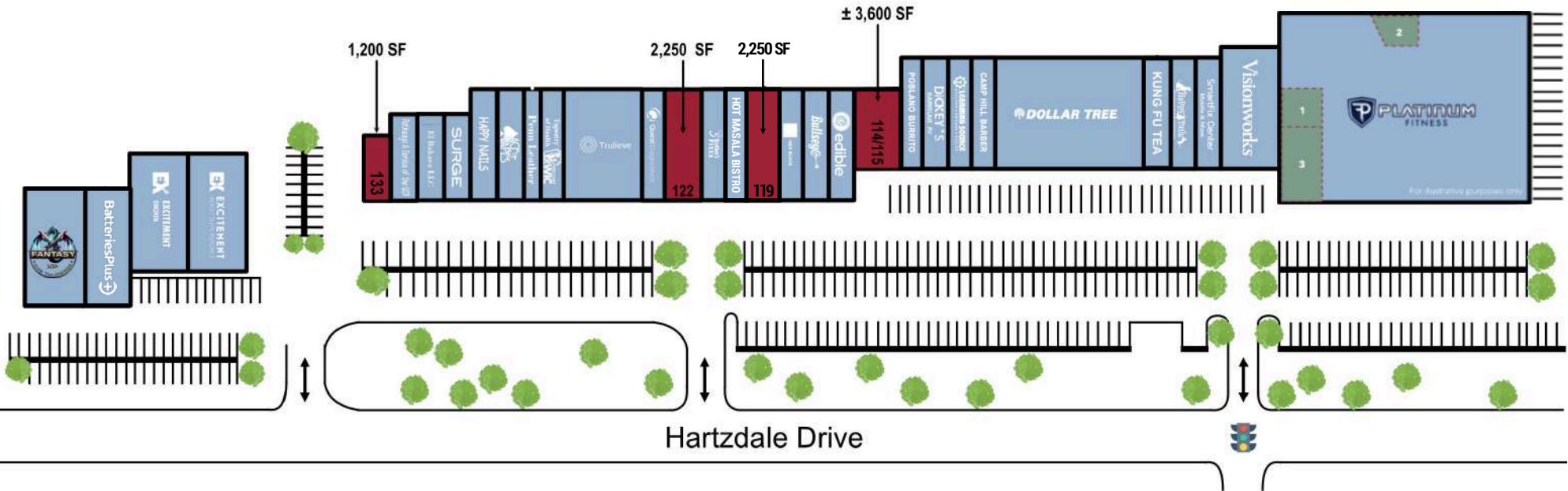

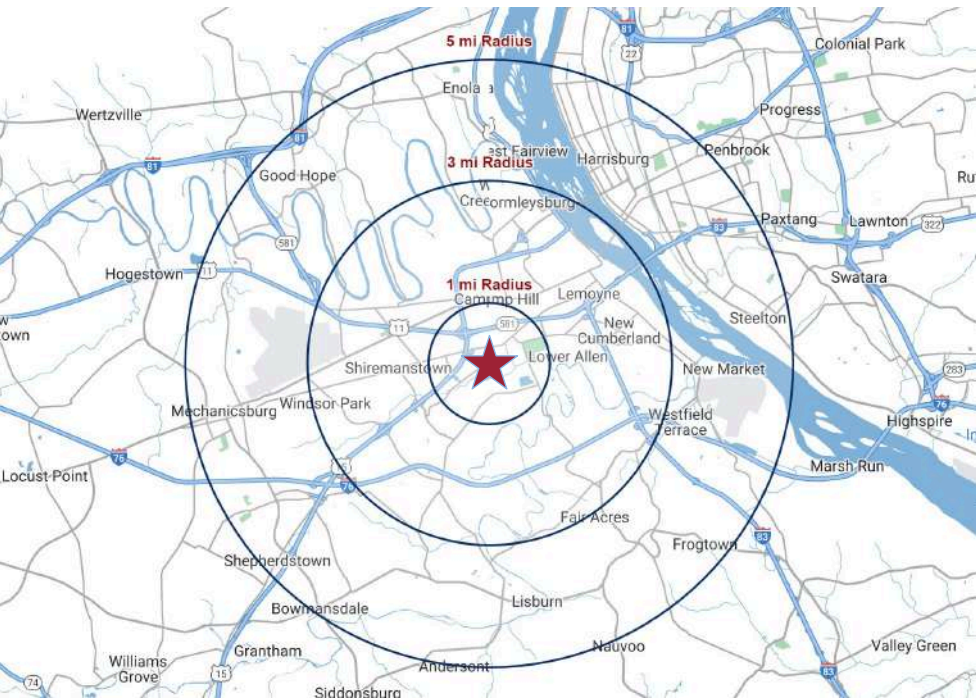
Demographics and Trade Area
