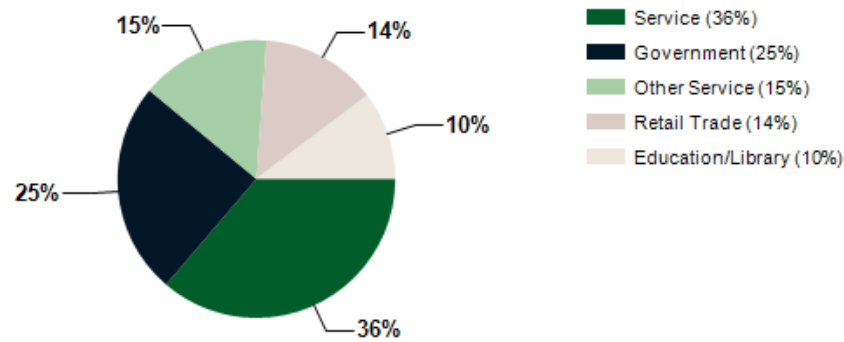

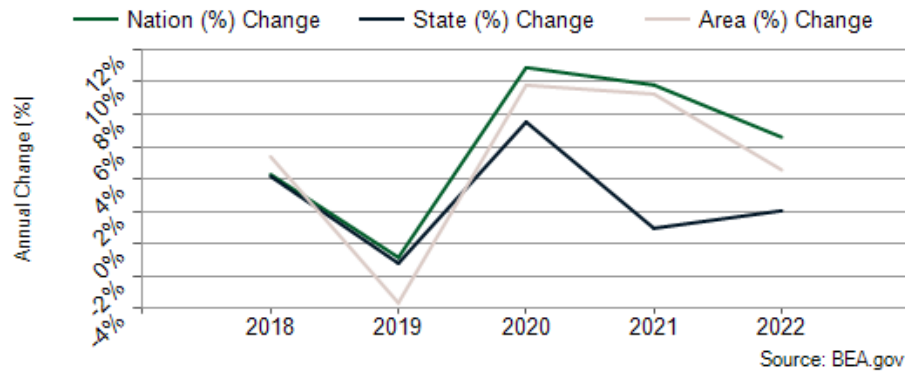

## Los Angeles County GDP Trend

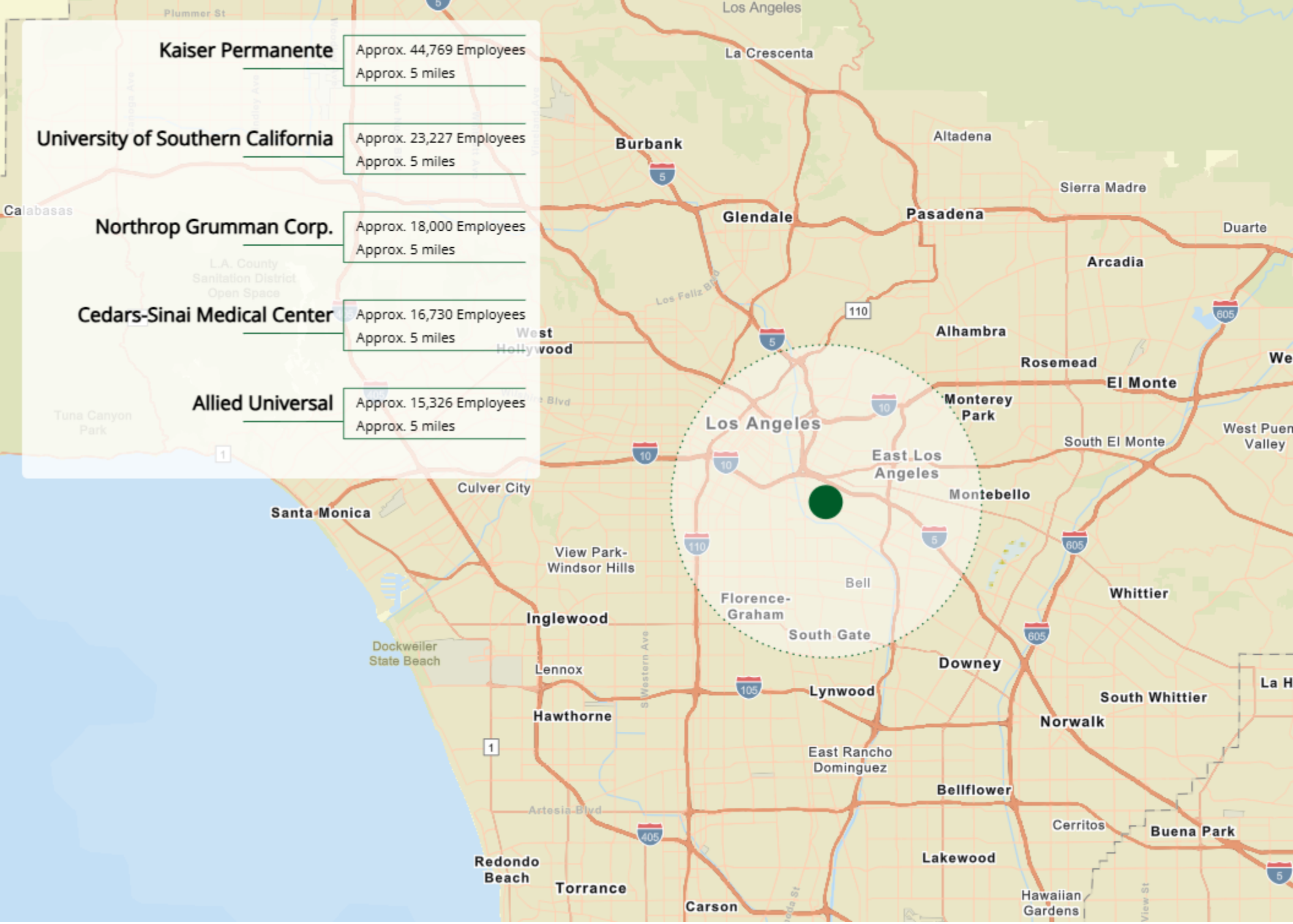


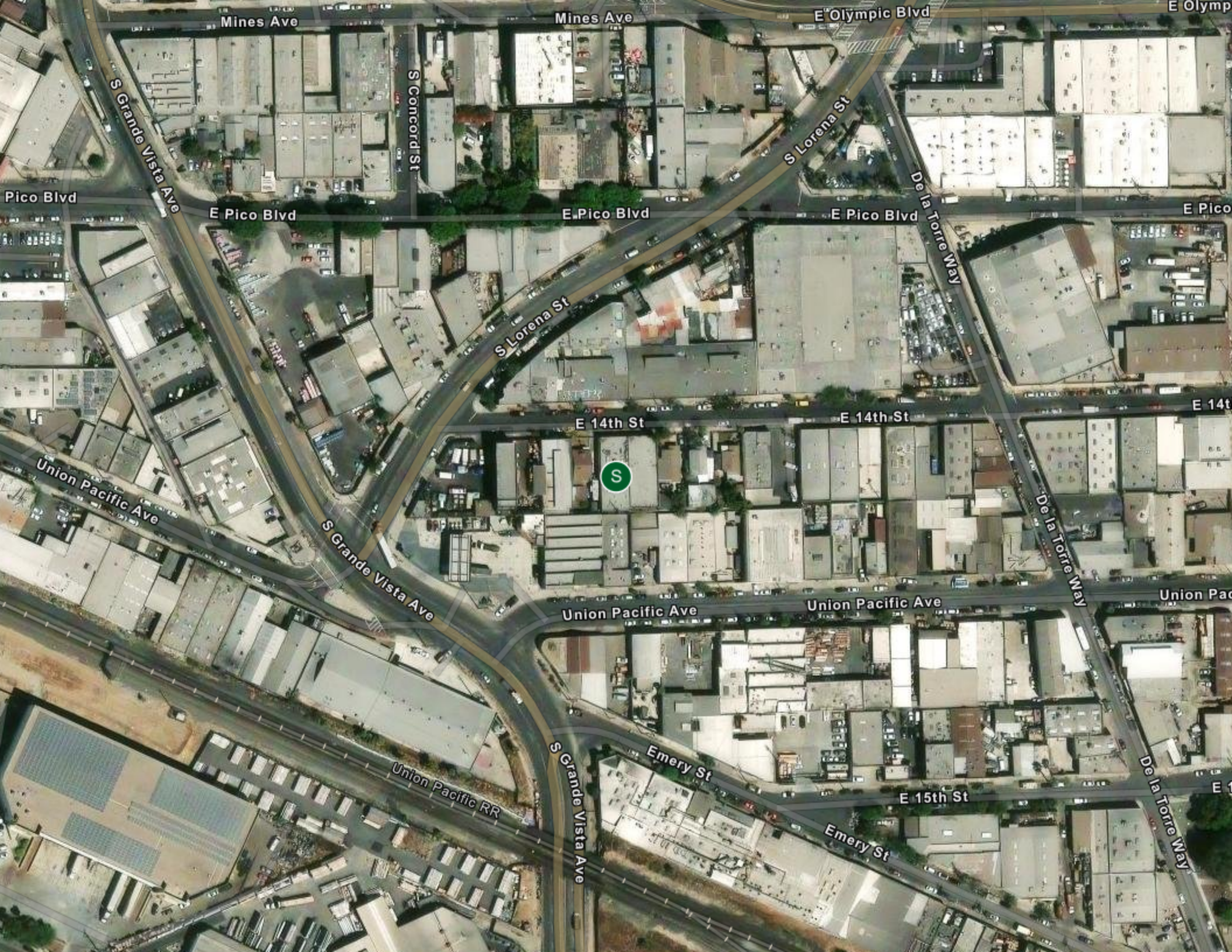

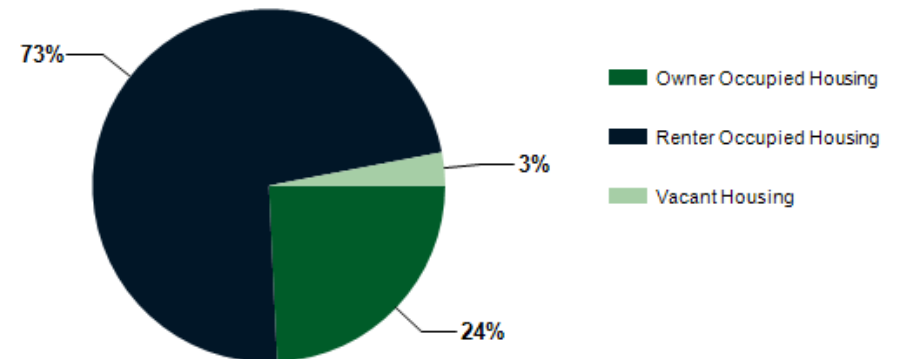

### 2026 Household Income



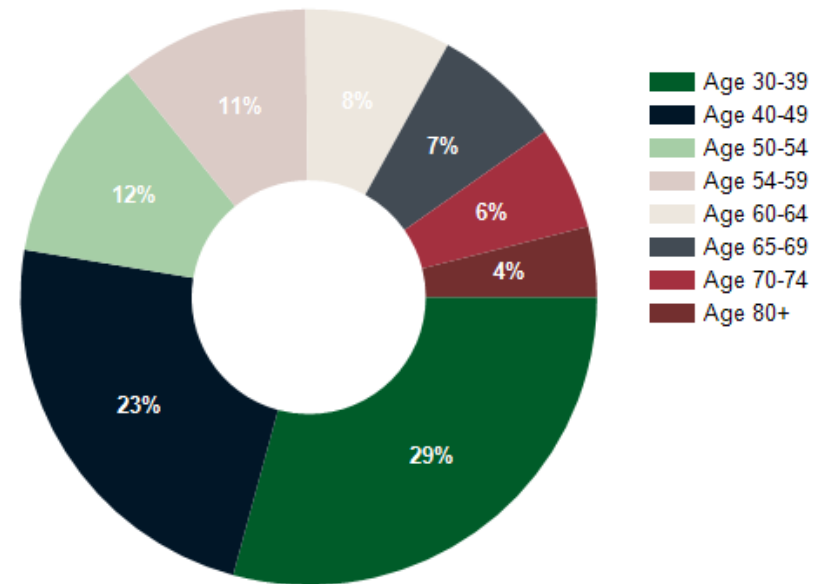
### 2026 Own vs. Rent - 1 Mile Radius



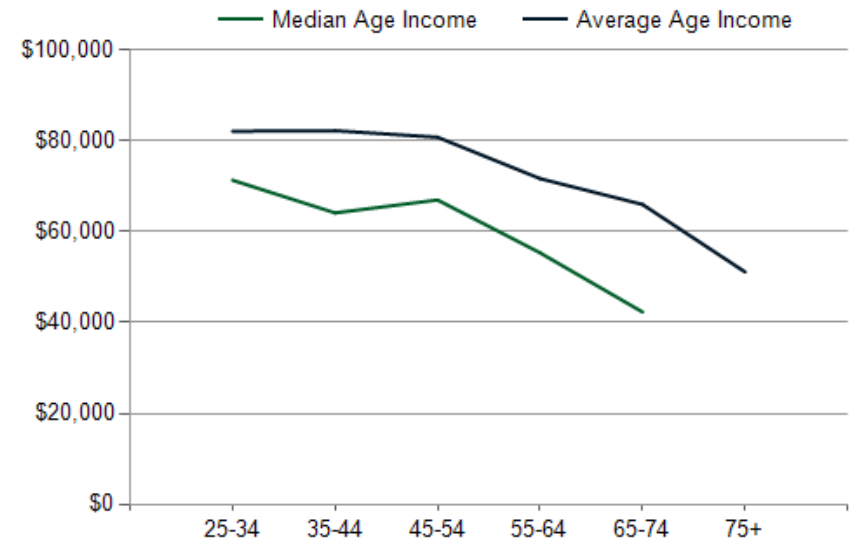

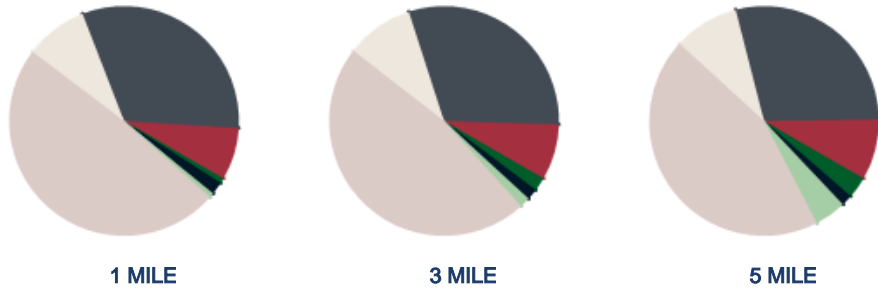

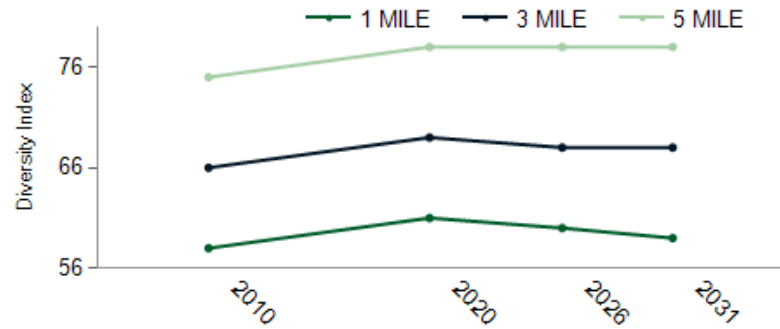

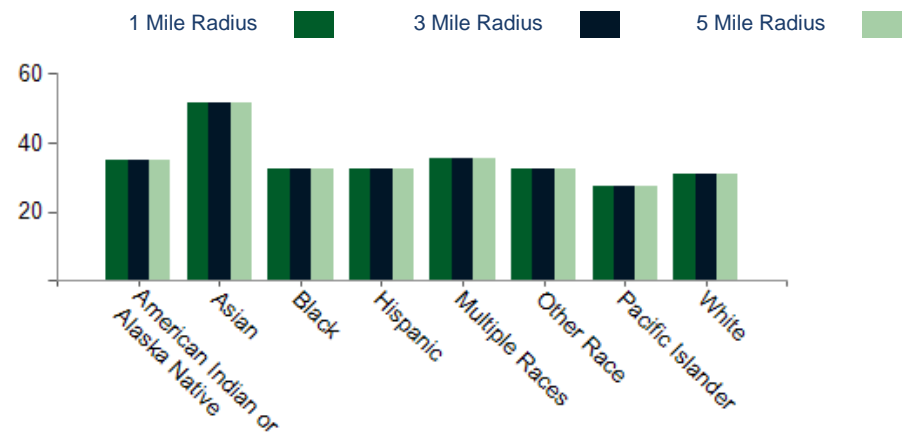
