Location

Cheswick Village is a large residential development in Bristol, approximately 5 miles north of the city centre. The area lies in the heart of a 77 acre plot between Filton, Lockleaze and Stoke Gifford and has been redeveloped to provide over 1,000 new homes.

The Square offers a number of commercial units, providing amenity to the residents and students in the area. The Square sits adjacent to Wallscourt Farm Academy School.

Current occupiers of The Square at Cheswick include Co-op, Boston Tea Party, Barnardo's, Happy Days Nursery and a number of independent businesses including a delicatessen, gym and Chinese takeaway.
